1. APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were received from Councillors D Cullen, E Harrington and A Webb.

2. MINUTES - COUNCIL - WEDNESDAY 24 FEBRUARY 2016

It was **RESOLVED** that the Minutes of the Council meeting of 24 February 2016 be approved as a correct record and signed by the Mayor subject to the correction of the following typographical error in item 5 - the first line of paragraph 7 on page 4 should read 'The Leader of the Liberal Democrats' and not 'The Leader of the Liberal Democratic Party' as stated.

At this juncture the Mayor made a speech in which he spoke about the engagements he had undertaken and he thanked everybody that had supported him in particular his Mayoress Jennifer Higgins, the Deputy Mayor and Mayoress Councillors John and Joan Lloyd and Tracey Frost from Member Services.

3. APPOINTMENT OF MAYOR

The Mayor asked for nominations for the Office of Mayor for 2016/17.

Councillor S Taylor OBE CC nominated Councillor J Lloyd CC for the Office of Mayor.

The nomination was seconded by Councillor S Batson MBE DL CC.

There being no other nominations a vote was taken and it was **RESOLVED** that Councillor J Lloyd CC be elected as Mayor for the 2016/17 Municipal Year.

Councillor Lloyd then made the statutory declaration of office.

The Mayor announced that his wife, Councillor Mrs Joan Lloyd would be his Mayoress for 2016/17.

In his speech the Mayor announced that his charities for the year would be the Pheonix Group for Deaf Children based at the Hyde and the Garden House Hospice.

The Mayor then presented awards to the following Members:

- For 20 years' service Councillors R Henry CC, M Notley and S Speller
- For 25 years' service Councillors M Downing and P Stuart
- For 30 years' service Councillor R Parker CC
- For 40 years' service Councillor Mrs J Lloyd.

On behalf of the Council Councillor J Thomas received a Housing Excellence award from the Mayor for the Ditchmore Lane project.

4. APPOINTMENT OF DEPUTY MAYOR

It was moved and seconded that Councillor P Stuart be appointed as Deputy Mayor for the 2016/17 Municipal Year.

There being no other nominations a vote was taken and it was **RESOLVED** that Councillor P Stuart be appointed Deputy Mayor for the 2016/17 Municipal Year.

Councillor Stuart then made the statutory declaration of acceptance of office.

The Deputy Mayor announced that Mr Tony Turner would be her consort for the 2016/17 Municipal Year.

5. APPOINTMENT OF YOUTH MAYOR

The Mayor thanked the outgoing Youth Mayor, Yvan Tiako, for his work as a representative for the young people of Stevenage and as an ambassador for the town.

Yvan Tiako then made a short speech in which he said that his time as Youth Mayor had been a life changing year which he would never forget. He thanked those that had helped him through the year and concluded by saying that the future of the town was bright and that he hoped that young people in the town would grow with a sense of purpose.

Council was informed that following an election the Youth Council had nominated Emma Chapman as the 2016/2017 Youth Mayor.

It was moved, seconded and **RESOLVED** that Emma Chapman be elected as Youth Mayor for the 2016/2017 Municipal Year.

In her acceptance speech the Youth Mayor stated that she was proud to be offered the opportunity to represent the young people of the town and she thanked those that had made her election possible. She added that she wished to raise the profile of young carers within the Borough.

6. BOROUGH COUNCIL ELECTIONS

The Leader thanked all those involved in the elections and welcomed new and re-elected Councillors to the Chamber.
