1. PURPOSE

1.1 To bring to the Executive's attention a request from the Stevenage and East Herts Joint Revenues & Benefits Executive Committee to amend that body's terms of reference.

3. BACKGROUND

3.1 At the meeting of the Stevenage Executive held on 7 June 2016 the Stevenage & East Herts Revenues and Benefits Joint Executive Committee was established with the following terms of reference –

- 1. To approve the annual Service Plan for the Share Revenues and Benefits Service.
- 2. To receive explanations of variances in service performance against the agreed Service Plan.
- 3. To approve the budget of the Shared Service and where so delegated determine requested virements within that budget.
- 4. To give initial consideration to future development of the Shared Service and any changes in legislation that may affect service delivery and make recommendations thereon to the Executive or Officers.
- 5. Where it is considered appropriate, report to the Executives of the Constituent Councils.
- 3.2 It is a matter for the Executive to determine whether or not the terms of reference for the Joint Committee are to be amended.

4. REASONS FOR RECOMMENDED COURSE OF ACTION AND OTHER OPTIONS

- 4.1 At its meeting on 15 June 2016 the Stevenage & East Herts Revenues and Benefits Joint Executive Committee considered a report from the Head of Revenues and Benefits Shared Service that provided an annual update.
- 4.2 Section 2.16 of that report, concerning the Joint Committee's terms of reference is appended to this reference.
- 4.3 Having considered the report the Stevenage & East Herts Revenues and Benefits Joint Executive Committee resolved to recommend the revised terms of reference as quoted.

2.16.1 Terms of Reference (TOR)

The minutes of the Joint committee meeting of 19 January 2016 record that it was resolved;

- 1. That the report be received and noted.
- 2. That the Committee meet annually in June, and
- 3. That the responsibility to complete budget preparations for the shared service be delegated to the Section 151 Officers
