5 REVIEW OF PRIVATE HIRE DRIVERS LICENCE - MR R

The Chair introduced the Members, the Principal Solicitor and Committee Clerk to Mr R.

The Committee considered the facts of the case, as presented by the Licensing Manager. The Committee was advised that the issue before the Committee was to determine whether Mr R remains a fit and proper person to hold a Private Hire Driver's Licence, and whether action is necessary as a result of that decision.

The Chair then invited Mr R to present his case to the Committee. The Members asked Mr R a number of questions relating to his motoring offences.

The Licensing Manager and Mr R both made closing speeches, after which all parties except the Members, Legal Advisor and Committee clerk withdrew from the meeting whilst the Committee considered the matters raised.

Following thorough consideration of the case by Members, Mr. R and the Licensing officers were invited back into the meeting to hear the Committee's decision.

It was **RESOLVED** that having considered all the evidence no further action would be taken against Mr R, however if there are any further similar convictions, Mr R would be brought before this Committee for reconsideration; and in that case Mr R's previous convictions will be taken into consideration.
