# APPLICATION FOR VARIATION OF PREMISES LICENCE - THE RISING SUN

#### 1 PURPOSE

To determine the application to vary the premises licence for the Rising Sun, 35 Julian's Road.

There have been no objections to the conversion application for this premises, so they will be granted their existing hours and activities as grandfather rights regardless of the decision related to the variation application.

## 2 SUMMARY OF APPLICATION

# 2.1 Type of Licence applied for

An application was received from Alan Richard Palmer to vary a premises licence under section 34 of the Licensing Act 2003 during the transitional period (see appendix 1). The Licensing Authority accepted the application on 6 August 2005.

## 2.2 Summary of application

The Rising Sun is located in Julian's Road, Stevenage (see appendix 2a-b for premises plan and appendix 3 for location map).

The premises is a Public House and the applicants are entitled to have the existing Justices On-licence converted to a premises licence. This allows the sale of intoxicating liquor for consumption either on or off the premises, and the sale of hot food and/or drink in line with alcohol sales plus an extra 30 minutes. Recorded music may be played throughout the premises 24 hours per day in line with the provisions of Section 182 of the Licensing Act 1964.

The premises does not hold a public entertainment licence (PEL), but is permitted by virtue of the Justice's Licence to hold 'two in a bar' live music entertainments. Discos and karaoke are not currently permitted.

The variation application is to:

- Increase the hours for sale and supply of alcohol by up to 1½ hrs per day at the end of the evening each day of the week, closing 30 minutes later at 01:00hrs;
- To permit the sale of hot food/drink until 00:30hrs each day of the week;
- To permit live music, all types of recorded music including DJ, Karaoke, jukebox until midnight each day of the week;
- To permit the showing of films;

**Licensing Officer's Comment:** of these licensable activities, the pub is not currently permitted to hold karaoke, discos or to show films.

Sale of alcohol is permitted from 10am throughout our district due to the Petty Sessional Division exercising their discretion. This does not necessarily mean that this premises currently uses this right, but it should be converted onto their new licence.

## 4 BACKGROUND INFORMATION

## 5 PROMOTION OF LICENSING OBJECTIVES

The representations received relate to the objectives of the Prevention of Crime and Disorder and the Prevention of Public Nuisance. The operating schedule submitted by the applicant shows that those licensing objectives will be met as follows:

Please note that the operating schedule must be converted into conditions on the premises licence should the variation be granted.

## 5.1 THE PREVENTION OF CRIME AND DISORDER

- 5.1.1 Providing a 30 minute extension of opening hours after the end of the sale of alcohol will promote this objective as the last drink will be consumed less quickly with access to pub toilet facilities.
- 5.1.2 Not less than ten working days notice to be given to the Police when 'Event Days' are planned.

**Licensing Officer's Comment:** On 'Event Days' the applicant proposes to allow sale of alcohol from 11:00-01:30 with closing time 30 minutes later, 24 times per year at his discretion. Whilst the applicant proposes to give notice to the Police, there is no undertaking to give notice to the licensing authority. The TEN system should be used for this purpose.

5.1.3 Regular liaison with the Police.

**Licensing Officer's Comment:** The applicant is invited to confirm whether this would be achieved by membership of the Stevenage Pubwatch scheme and attending the associated meetings.

5.1.4 Proof of age verification to be used

**Licensing Officer's Comment:** the applicant is invited to confirm whether this will be in the form of photo-id such as driving licence/passport.

5.1.5 Zero tolerance policy on the supply or use of drugs.

## 5.2 THE PREVENTION PUBLIC NUISANCE

5.2.1 Regular noise checks during performance of regulated entertainment.

**Licensing Officer's Comment:** Environmental Health have recommended conditions that include more robust conditions with respect to entertainment noise.

- 5.2.2 Customer notices re: leaving the premises quietly.
- 5.2.3 Outside areas kept clean and tidy and bins emptied regularly.

5.2.4 No drinks to be taken off site apart from off-sales.

# **6 RESPONSIBLE AUTHORITIES**

# 6.1 Environmental Health – see appendix 4

Environmental Health have made representations relating to the prevention of public nuisance. They state that there is a history of noise complaints relating to this premises, and that there is a concern that the increase in hours and the provision of live music is likely to cause a nuisance to local residents.

5 conditions have been proposed by Environmental Health in order to prevent public nuisance, and these are within the representation attached as appendix 4.

## 6.2 Police – see appendix 5

The Police have made representations relating to the prevention of crime and disorder and public nuisance.

## **Prevention of Crime and Disorder**

In 2005 there have been 7 incidents relating to the premises that have required police attention, 5 of these involving alcohol related disorder; in the whole of 2004 there was one incident. The Police are concerned that if the hours for supply of alcohol are significantly extended it could lead to increased incidents of crime and disorder.

## **Prevention of Public Nuisance**

The Police are concerned that this premises is bordered by residential premises, and there are genuine concerns about additional disorder as patrons are more likely to become intoxicated if the hours for supply of alcohol are increased.

No representations have been received from the Fire and Rescue Service, Trading Standards, Child Protection or Planning.

## 7 INTERESTED PARTIES

Representations have been received from the interested parties below, and their representations are attached as appendices 6a - 6j. A total of 10 addresses have made representations; they are all within 120 metres of the premises.
