1 APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were received from Councillors Jody Hanafin, Liz Harrington and Andy McGuinness.

There were no declarations of interest.

2 MINUTES - 27 FEBRUARY 2020

It was **RESOLVED** that the Minutes of the meeting of the Committee held on 27 February 2020 be approved as a correct record and signed by the Chair.

3 GAMBLING ACT 2005 - REVIEW OF STATEMENT OF PRINCIPLES

The Committee considered a report in respect of the proposed draft Gambling Act 2005 Statement of Principles 2022 - 2025. The existing Statement had been adopted by the Council in July 2019 and was therefore due for a review.

The Chair announced that there had been no changes nationally to the Gambling Act 2005 ("the Act"). The responsibility for licensed gambling premises was split between the local authorities and the Gambling Commission, with the former dealing with smaller local operators and the latter dealing with national organisations and large lotteries.

The Commercial and Licensing Manager advised that the Council's Gambling Act 2005 Statement of Licensing Principles sets out the general approach the Council would take when carrying out its regulatory role under the Act and promoting the three licensing objectives of:

- preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime;
- ensuring that gambling is conducted in a fair and open way; and

 protecting children and other vulnerable persons from being harmed or exploited by gambling.

The Commercial and Licensing Manager explained that the Act was conceived as 'light touch' legislation, covering a wide range of licensable activities such as adult gaming centres and betting premises. The Act specified that Local Authorities should "aim to permit" gambling, provided it was in accordance with the Code of Practice and guidance issued by the Gambling Commission, reasonably consistent with the licensing objectives and in accordance with the Statement of Principles. The effect of this duty was that Licensing Authorities must approach their functions in a way that sought to regulate gambling by using their powers to promote the licensing objectives, rather than by setting out to prevent it altogether.

The Committee noted that the Statement of Principles sought to strike a balance between the interests of licence holders, applicants and residents in the promotion of the licensing objectives defined by the Act. Additionally, it outlined the licensing authority's expectations of licence holders in promoting the licensing objectives, whilst advising on the licensing authority's obligations under the Act, including its interpretation of the Act and/or Statutory Guidance where necessary. The Statement was designed to offer appropriate protection for residents and a streamlined approach to regulation that eased unnecessary burdens on businesses.

The Commercial and Licensing Manager stated that the draft Statement of Principles was attached at Appendix A to the report. Significant additions or variations from the 2019-2022 Statement had been highlighted in yellow. The Statement included new sections on Applications (A4), Authorisations under the Act (A5), the Gambling Commission (A6), Protecting children and other vulnerable persons from being harmed or exploited by Gambling (B3.12-20), Environmental considerations (C3), Public Health and Gambling (C4).

The Commercial and Licensing Manager explained that, to accompany the revised Statement of Principles, a local area profile was undertaken. The local area profile aimed to summarise existing national research relating to gambling-related harm, and to identify potential risks relating to vulnerable groups and/or geographical areas within Stevenage. The local area profile was attached at Appendix B to the report.

The Committee noted that he local area profile had identified that Bedwell Ward revealed potential risks as this area had a number of gambling premises (due to the Town Centre being part of Bedwell) and also being an area of high deprivation in the Borough. However, there was no evidence to identify that gambling was causing harm to children or vulnerable adults in Bedwell or elsewhere in the Borough of Stevenage.

The Commercial and Licensing Manager advised that consultation on the proposed draft Statement of Principles 2022-2025 took place between 15 November 2021 and 19 December 2021. Responses were received from Power Leisure Bookmakers (attached at Appendix C to the report), the Betting & Gaming Council (attached at Appendix D) and POhWER (attached at Appendix E). The Licensing Authority's comments regarding the issues raised in these responses, together with proposed amendments to the Statement of Principles arising therefrom, were set out in

Paragraphs 3.15 to 3.24 of the report.

Members' comments and questions centred on the proposed new Local Area Profile (LAP), and the following points were raised:

- it was confirmed that two of the three consultation responses were received from gambling industry operators, and that with the exception of the reply from POhWER (a charitable membership organisation that provided information, advice, support and advocacy to people who experienced disability, vulnerability, distress and social exclusion), no responses had been received from other stakeholders, such as national or local charities;
- the LAP would be an evolving document, but would require strengthening once further work was undertaken on evidence gathering from various sources, including the Gambling Commission, Citizens Advice Bureau, the Police and Housing providers. HCC Public Health was keen to move forward with a collaborative approach to tackling gambling issues, which would include the establishment of a robust evidence base. It was hoped that this would also cover child protection and any data relating to "hidden" gambling issues;
- the evidence base should also include any relevant data to be gleaned from local gambling operators, as well as from the online gambling industry;
- the Chair considered that it may require primary legislation to address the potential harmful risks associated with gambling, particularly amongst vulnerable groups;
- it was clarified that "ensuring that gambling was conducted in a fair and open way" was essentially to ensure that operators abided by legal stipulations and in accordance with the Gambling Commission's Code of Practice;
- it was confirmed that the Licensing Team received very few complaints in respect of the gambling organisations/premises operating in the Borough. There would be routine inspections of premises by the Licensing Team and each would be risk-rated, meaning that there would be a more regular inspection regime for those premises rated towards the higher levels of the risk range. In terms of enforcement, this included a worst case scenario of licence revocation, but could also involve a requirement for improvements and restrictions of certain activity;
- in terms of the process for logging complaints, Members were advised that complaints could be registered through the Council's website, and that gambling operators were required to display their licence at their premises (which included the contact details for the SBC Licensing Team);
- although the HCC Public Health Team was encouraging a collaborative approach towards tackling gambling issues, the Hertfordshire and Bedfordshire Local Authorities Licensing Managers met every 6-8 weeks to share feedback and good practice on licensing and gambling matters; and
- it was confirmed that the representation received from POhWER contained a series of queries and questions which would be responded to separately and did not affect the Statement of Principles. However, Members felt that consideration should be given to inviting a representative(s) from a charitable organisation to a future meeting of the Committee in order to hear their views on gambling issues.

The Committee supported the Licensing Officer's proposed amendments to the Statement of Principles in response to issues raised during the consultation process, as set out in Paragraphs 3.15 to 3.24 of the report.

It was **RESOLVED**:

- That the proposed Stevenage Borough Council Gambling Act Statement of Principles 2022 – 2025, as attached at Appendix A to the report, and with the inclusion of the amendments proposed by the Licensing Officer in response to issues raised during the consultation process set out in Paragraphs 3.15 to 3.24 of the report, be agreed.
- 2. That the amended draft Statement of Principles be recommended to the Executive, for onward recommendation to Council.

HACKNEY CARRIAGE TARIFF REVIEW

1 PURPOSE

1.1 To review the current hackney carriage fares tariffs following a request from hackney carriage drivers to revise them.

2 **RECOMMENDATIONS**

2.1 That the Committee determines whether the proposed tariff should be imposed without modification, imposed with amendments or abandoned.

3 BACKGROUND

- 3.1 The fixing of fares for hackney carriages within the district is governed by the Council by virtue of section 65 of the Local Government (Miscellaneous Provisions) Act 1976. This must be published by means of a tariff table. The last change in fares took effect on 3 July 2017; a copy of the current tariff table is attached as Appendix 1.
- 3.2 At a Taxi Forum on 14 December 2021, members of the trade requested that the current tariffs should be revised. They were advised by the Licensing Officer to submit this request in writing, explaining why an increase was considered necessary.
- 3.3 A written request to consider an increase was received by the Licensing team on 5 January 2022 from 8 drivers of ABC Taxis Limited, co-ordinated by Paul Barrett. A

copy of the written request and the list of supporting drivers is attached as Appendix 2.

- 3.4 Following clarification of the detail of the proposal with Paul Barrett, the proposed tariff table was consulted upon. Drivers and operators were consulted via email and letter for the period of 24 January to 11 February 2022. Due to an administration error, this notice was not placed in the local paper for the required 14 days. Hence a further, updated Notice was advertised in the local press from 17 February to 24 February and 3 March to 10 March 2022 and a copy made available for inspection at the Council offices for the same period in accordance with the legislation. Copies of the newspaper notices are attached as Appendix 3 and a copy of the public notice is attached as Appendix 4.
- 3.5 In addition, a letter was sent to all licensed drivers and licensed private hire operators in the Council's area advising recipients of the review proposal. A copy of this letter is attached as Appendix 5.
- 3.6 The public notices required any objections to the proposal to be made in writing. The consultation period extended until 11 February for drivers and operators. Due to the administration error discussed in 3.4 above, the public consultation ran from 17-24 February and 3-10 March 2022. For drivers and operators, objections had been received from four persons, all dual licensed drivers. Copies of the four individual objections are attached as Appendices 6 to 9.

4 DISCUSSION

- 4.1 The proposed Tariff 1 charge for a 2 mile journey represents an increase of 9.3% on the current Tariff 1 charge. The new proposal is to reduce the length of the first charge from 0.5 mile to 0.3 of a mile and for each subsequent 0.1 of a mile travelled, twenty pence will be added for the length of the journey. Tariff 2 & 3 have also been updated and demonstrates a 9.3% increase for Tariff 2 and an 11.1% increase for Tariff 3.
- 4.2 The Private Hire and Taxi Monthly magazine, a trade publication, maintains a national fare table which provides useful comparisons of taxi tariffs between local authorities. The proposed tariff would place Stevenage at 29th equal in the national ranking compared with the current ranking of 111th out of 365 licensing authorities in the country. The position in Hertfordshire and Bedfordshire is summarised in table 1 below.
- 4.3 If the proposed tariff were adopted Stevenage fares would be on a par with Edinburgh, Harrogate, Stroud and locally Hertsmere & Welwyn-Hatfield.; a total of 7 local authorities currently have a charge of £7.00 for a two mile journey.
- 4.4 The proposed increase was considered warranted due to costs resulting from COVID (masks, cleaning equipment), the common use of card payment facilities that incur a transaction fee and the rising costs of living, incorporating fuel, maintenance, replacing vehicles and station permits. In July 2017 the average price of a litre of unleaded petrol was 114.33 pence while a litre of diesel was 115.02 pence. In February 2022 the average prices were 151.16 pence and 154.75 pence respectively (source: RACfoundation.org)

- 4.5 In regard to other motoring costs over the same period, all costs of motoring have increased by 23.9% with maintenance costs having increased by an average of just under 16% while tax and insurance have increased by an average of 25% (source: RACfoundation.org).
- 4.6 In terms of changes in the cost of living in cost of living, the Consumer Prices Index including owner occupiers' housing costs (CPIH) 12-month rate of 2.6% for July 2017. The level in 2017 was at a peak and at the start of a general fall in the cost of living until January 2021. From January 2021 until December, there has been a very steep rise in the cost of living, with December 2021's figure at 4.8% (source:www.ons.gov.uk).
- 4.7 The four objections have cited very similar reasons as to why a tariff increase is not warranted. Two of the four objections see taxis as a luxury and all are concerned in the general rising cost of living affecting usage. All are concerned that this will enable UBER to undercut fares charged by drivers within Stevenage.
- 4.8 Uber's operating model enables them to price journeys very competitively during certain periods and they are not subject to hackney carriage tariffs. The trade's fear is that implementing the new tariff would put hackney carriage drivers at an even greater competitive disadvantage. However it is worthy of note that the proposed hackney carriage tariff is designed to limit *maximum* fares and it is within the gift of a hackney carriage driver to charge less than the tariff fare. Uber's pricing structure is complex and does not bear easy comparison but anecdotally it is known that their

fares do not necessarily differ significantly from those of other providers, often depending on the time of day and level of demand in real time.

- 4.9 In Stevenage hackney carriages are required by licence conditions to be fitted with taximeters. Private hire vehicles may also fit taximeters, and in practice many do, but the tariff only applies by law to hackney carriages. The extant tariff must be programmed into hackney carriage taximeters, which are then bound by the fare displayed on the meter at the end of the journey; that is they must not charge any more than the figure displayed. Private hire drivers and operators have an interest in the hackney carriage tariff since it may be programmed into their taximeters but in practice they are entitled to charge any fare they desire, provided it has been agreed with the passenger or passengers before a journey begins.
- 4.10 A number of the larger operators in Stevenage charge in accordance with fixed price promotions on a permanent basis; £8 maximum fee for one pick up and drop off in the Stevenage area from 9am to 9pm. In certain instances this could result in fares for longer journeys within the town made with private hire vehicles and drivers operated by these companies undercutting the cost of equivalent journeys in a Hackney Carriage. Journeys in a private hire vehicle could only be made following advanced booking however. It should also be noted however that the income of large operators depends largely on the number of drivers they have on their circuits and the extent of their penetration of the corporate and contract markets rather than fare levels per se.
- 4.11 In summary, the proposed tariff revision appears reasonable given the increased fuel costs associated with running a vehicle but there is a limited but clear objection to the tariff rise; there are concerns that the rise will isolate customers from using hackney carriage or private hire vehicles.

5 OPTIONS FOR ACTION

- 5.1 Committee is now invited to review the proposed taxi tariff change. The options are to:
 - Accept the proposal as submitted and apply the new tariff effective from a date not more than two months after the operational date specified in the public notice (2 April 2022).
 - b) Modify the submitted proposal and apply the new tariff effective from a date not more than two months after the operational date specified in the public notice (2 April 2022).

c) Leave the current tariff in place unaltered. There is no specific facility in the legislation to enable this and so in effect the current tariff would have to be re-implemented following the process at b) above.

6. IMPLICATIONS

6.1 Financial Implications

6.1.1 There are no direct resource implications for the Council arising from the content of this report.

6.2 Legal Implications

- 6.2.1 There is no right of appeal against the fares once set. The only remedy for an aggrieved party would be to seek a judicial review.
- 6.2.2 The Committee's attention is also drawn to section 17 of the Crime and Disorder Act 1998, which requires local authorities to consider the community safety implications of all their activities. This is a corporate responsibility of the authority as a whole.

6.3 **Policy implications**

6.3.1 There are no policy implications arising from the content of this report.

6.4 Equalities and Diversity Implications

6.4.1 Any decision by the Committee is based on evidence before it at the meeting; there are no equalities and diversity implications arising from this report.

Stevenage Borough Council – Passenger Fare Guide

Taxi fares from 3rd July 2017

The meter calculates the maximum fare based upon the time of day, the distance travelled and the vehicle speed. **N.B. The meter should not be started until the journey commences**

Drivers must, <u>unless they have good cause</u>, accept any hiring that is wholly within the Stevenage boundary. <u>Hirings beyond the Stevenage boundary are at the discretion of the driver.</u>

The fare for a journey to a destination outside of the Stevenage boundary may be negotiated between the driver and hirer. If no fare is agreed before the start of the journey, the fare cannot be more than that shown on the meter.

Typical fares:

Note that fares and times may be higher than shown dependent on delays or slow moving traffic. The fare shown, on the face of the meter, at the conclusion of the journey is the **maximum fare** that can be demanded; <u>unless previously agreed with the driver as above.</u>

Hi Julie

I hope you had a lovely Christmas and Happy New Year to you.

Recently, during the Christmas & New Year period, drivers lost money during the Bank Holidays. This was due to their Taxi Meter Calender Contolled Tarrif being expired, most taffif's only last around 2-3 years. We require to make sure these meters are updated before the first Bank Holiday, which, is the 15th April 2022.

Also, we would like to propose an increase in the Hackney Carriage taxi fare, due to extra costs of covid, cleaning equipment and masks. The majority of drivers now accept card payments, however, each driver loses between 1.6% - 3.0% of each fare due to the processing costs.

Our last increase was in July 2017. Due to the rising cost of living, station permits, fuel, maitenance and the price of replacing vehicles, we would like to see an increase in the cost of the Journey by 60 pence.

To acheive this, we would like to add 20 pence to the meter start, therefore increasing to ± 3.60 for the first 528 Yards.

Justice for postmaster

A wrongful conviction was overturned



Abiodun Omotoso was 33 when he was wrongfully convicted of the theft of more than £50,000 from a Hitchin post office - the ruling was overturned in 2021

A former sub-postmaster from Hitchin who was jailed in 2008 after being accused of stealing £50,000 from the Post Office has had his conviction quashed amid a national scandal.

Aibodun Omotoso, who was in charge of Walsworth Road Post Office, was wrongly convicted for theft from his workplace and sentenced to two years and four months in prison at the age of 33

A public inquiry launched

into the scandal on Monday. There were around 700 similar cases of wrongful conviction after the UK Post Office introduced the Fujitsu Horizon computer accounting system in 1999, which caused unexplained discrepancies and losses.

Throughout the case Mr Omotoso maintained his innocence, after initially telling the police he borrowed the money to get treatment for a sick relative in Nigeria, because he was told his truthful account would not be believed and if he accepted liability the matter could be dealt with internally.

Proposed Taxi fares from 1st April 2022

The meter calculates the maximum fare based upon the time of day, the distance travelled and the vehicle speed. **N.B. The meter should not be started until the journey commences**

Drivers must, <u>unless they have good cause</u>, accept any hiring that is wholly within the Stevenage boundary. <u>Hirings beyond the Stevenage boundary are at the discretion of the driver.</u>

We are still in the grips of a global pandemic, when people are struggling to make ends meet you are asking us to charge them more.

The majority of people do not have this luxury and are on set incomes. Asking them to pay more for their journeys is more than likely only going to get them to stop using taxis completely or turn to Uber.
