#### 1 APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were submitted on behalf of Councillors Myla Arceno, Rob Broom, Nazmin Chowdhury, John Duncan, Bret Facey, Liz Harrington, Chris Howells, Graham Lawrence CC, Andy McGuinness, Claire Parris and Lorraine Rossati.

There were no declarations of interest.

#### 2 MINUTES - 10 MARCH 2023

It was **RESOLVED** that the Minutes of the meeting of the Licensing Committee held on 10 March 2023 be approved as a correct record and signed by the Chair.

All parties noted the revised procedure for the hearing which had been circulated at the meeting.

# 4 APPLICATION FOR THE GRANT OF A PREMISES LICENCE - TODAY FISH AND GRILL, 10 MIDDLE ROW, STEVENAGE SG1 3AW

The Committee considered an application for the grant of a premises Licence for the Today Fish and Grill, 10 Middle Row, Stevenage, SG1 3AW. Representations in respect of this application had been made by two local residents, one residing on Middle Row and the other on Baker Street. A representation had also been made from the owner of a local business on Middle Row.

Representations received by two of the Responsible Authorities, the Local Planning Authority and Environmental health had been withdrawn following the Licensing officer liaising with the Applicant who had subsequently agreed to voluntarily amend their application for late night refreshment from 03:00hrs to 00:00hrs for both delivery and takeaway and would be closed to the public at 00:00.

The Licensing Officer presented a report to the Committee outlining the facts of the application.

The Licensing Officer advised that the premises was surrounded by other commercial properties including retail outlets and a Barber shop along with some residential properties located above some of the ground floor premises on Middle Row. There were also nearby premises providing late night refreshments.

Following a question to the Licensing Officer from a local resident, it was clarified that the application was for the grant of the licence between the hours of 11.00am and 00:00midnight Mondays to Sundays including Bank Holidays.

A request was made by a local resident that the Committee defer their decision on the application as there were flaws and accuracies in the application including the lack of an accurate plan with dimensions of the property.

The Chair then invited the local residents to present their case. Two local residents spoke of their objections to the application, their key points of objection being:

- A number of late night licences in the vicinity were already in existence and caused nuisance. The grant of this licence would add to that nuisance;
- In general, there were no objections to the night time economy in the Old Town, however, the use of middle Row for such a premises would create considerable noise nuisance to the residents of Middle Row;
- The narrowness of Middle Row did not allow large groups to congregate without causing disturbance;
- Vandalism had been experienced in the past and an additional premises would increase the chance of further vandalism, particularly as Middle Row was secluded and out of sight from the High Street;
- The lack of public conveniences in the area could also lead to further antisocial behaviour;
- The inaccuracies of the plan submitted with the application did not show the issues with regard to the access into the residential premises at 12 middle Row.

The local residents responded to a series of questions asked by the Applicant's representative and members of the Committee.

The Chair then invited the Applicant's representative (Mr Stewart Gibson) to present their case.

Mr Gibson's submission included the following points:

- The objections raised to the application had no bearing and were not relevant to the 4 licensing objectives;
- Following consultation with the Licensing Officer and in response to concerns raised by the Responsible Authorities and local residents, the applicant had voluntarily amended the application by bringing forward the finish time for late night refreshment from 03:00hrs to 00:00hrs for both delivery and takeaway. The premises would also close to the public at 00:00hrs.

- The opening of the premises would not cause an increase in the numbers of people coming to the area but would just provide more choice to those people already in the area;
- The delivery partner waiting area would be removed from the application.
   Deliveries would be made through the adjoining Chickaroo premises which opened onto the High Street not Middle Row;
- No motorcycles would be used for the delivery of food it would be cars only which would address concerns of noise nuisance;
- No alcohol would be sold from the premises.

Mr Gibson and the Manager of Today Fish and Grill then answered a series of questions from local residents who had made representations, and Members of the Committee.

All parties were invited by the Chair to sum up their submissions.

At the conclusion of the summing up, the Committee withdrew from the meeting to determine the application. At the conclusion of that process, the Committee returned to the meeting to give their decision.

### **Licensing Committee Chair's statement:**

The Licensing Committee approved the grant of a premises licence for Today Fish and Grill, 10 Middle Row, Stevenage, SG1 3AW subject to inclusion of the additional licensing conditions as set out below:

- 1. The removal of the delivery partner waiting entrance at the front of the property;
- 2. All delivery collections to be made through Chickaroo's High Street entrance.

The Committee restated the requirement of the planning condition on the business that all activity including cooking and serving must be ceased by midnight.

The Committee also advised that should the Council receive a valid request for a review from a resident or residents or from a Responsible Authority, the Committee would be able to consider a review of the Licence.

All parties were advised of their right of appeal to the Magistrates Court within 21 days of the receipt of the decision notice.

- 1. The Chair will introduce himself/herself and invite the other Committee Members, the Licensing Officer(s), Legal Advisor, Committee Administrator, Responsible Authority representatives, interested parties and the Premises Licence Holder and any representative to introduce themselves.
- The Licensing Officer will outline the reason for the hearing and report on the facts of the case. Members of the Committee, the Responsible Authority representatives, members of the public who had submitted representations and Premises Licence Holder (and/or representative) may ask questions of the Licensing Officer.
- 3. The Responsible Authority representatives may then state their case, calling any witnesses.
- 4. With the Chair's permission, Members of the Committee and the Premises Licence Holder (and/or representative) may then ask questions of the Responsible Authority representatives.
- 5. The members of the public who have submitted representations may then state their case, calling any witnesses.
- 6. With the Chair's permission, Members of the Committee and the Premises Licence Holder (and/or representative) may then ask questions of the members of the public who have submitted representations.
- 7. The Premises Licence Holder (and/or representative) will state their case, calling any witnesses they wish.
- 8. With the Chair's permission, Members of the Committee, Responsible Authority Representatives and members of the public who have submitted representations may then ask questions of the Premises Licence Holder (and/or representative).
- 9. The Responsible Authority representatives are then invited to sum up.
- 10. The members of the public who have submitted representations are then invited to sum up.
- 11. The Premises Licence Holder (and/or representative) is then invited to sum up.
- 12. The Committee will retire to consider the matter and make its decision.
- 13. At the conclusion of its deliberations, the Committee will EITHER return to the meeting to deliver its decision OR inform all parties of its decision in writing as soon as possible after the meeting. In either event, reasons will be given for the Committee's decision.

#### 1 PURPOSE

1.1 To determine an application for the Variation of a Premises Licence for Taste of India, 48a High Street, Stevenage. SG1 3AW. The Planning Authority, Environmental Health and local residents have made representations.

# 2 RECOMMENDATIONS

2.1 That the Committee reviews the evidence presented by the responsible authorities, local residents and applicant (and/or representatives) and determines what action should result in respect of this application, for the grant of a premises licence.

#### 3 SUMMARY OF APPLICATION

3.1 Mr MD Shadikur Rahman has applied for the variation of the premises licence for The Taste of India, 48a High Street, Stevenage SG1 3EF. The premises wish to provide hot food/late night refreshment off the premises in

addition to on, by way of delivery. The application also proposes to extend the hours for the provision of late-night refreshment by 30 mins Friday, Saturday, and Sunday, so that late night refreshment is provided between the hours of 23:00 and 00.00 Friday and Saturday and between 23:00 and 23:30 on a Sunday.

- 3.2 The applicant has included with this application, a list of additional conditions which are to be included in the operating schedule to promote the four licensing objectives in light of the proposed variation. These include the following:
  - There shall be no delivery of alcohol.
  - The premises shall ensure that all orders taken by the premises will be delivered to customers at a bona fide address.
  - No deliveries shall be made to an open space.
  - Delivery vehicles shall switch off their engines whilst stationary and collecting orders for delivery.
  - Delivery vehicles horns shall not be used except in accordance with the Highway Code
  - Notices will be displayed at the rear of the premises requesting staff to respect the local residents and use the area quietly.
- 3.3 This application was accepted as valid and duly made by the Council on 18<sup>th</sup> October 2023. **A copy of the application is attached at Appendix A.**

#### 4 BACKGROUND INFORMATION

- 4.1 The Taste of India is a restaurant/takeaway located in a three-storey terraced property on the western side of the High Street. The premises is surrounded by other takeaway food outlets which include the Old Town Fish Bar and The Surma Indian Takeaway. The premises is also located within the Stevenage Old Town Conservation Area.
- 4.2 There are also residential properties adjacent to the premises and some located on the upper floors. A location map is attached at Appendix B.
- 4.3 The Taste of India currently hold a premises licence which authorises them for the sale of alcohol, 10:00hrs to 23:00hrs Monday Saturday and between 12:00hrs and 22:30hrs on a Sunday. The provision of late-night refreshment (Inside) 23:00 23:30 Monday to Saturday and the playing of recorded music 00:00hrs to 24:00hrs. The hours for the sale of alcohol and the provision of late-night refreshment vary on New Years Eve and Bank Holidays. A copy of the premises licence and plan is attached at Appendix D.
- 4.4 The Licensing Officer carried out an inspection of the premises on 6<sup>th</sup> November 2023. The premises, at the time of the inspection was not selling alcohol and there was no alcohol being kept on site.

- 4.5 The Taste of India closed the restaurant side of the business during the COVID pandemic. The restaurant has not re-opened, and the business have been operating a takeaway/delivery only service since this time. They were unaware that their premises licence did not authorise them for the provision of late-night refreshment outside of the premises by way of delivery and have subsequently submitted this application for a variation of their premises licence.
- 4.6 Late night refreshment is the provision of hot food and/or drink and becomes a licensable activity between the hours of 23:00 and 05:00. The supply of hot food and/or drinks takes place when it is given to the customer and not when payment is made.
- 4.7 The Surma Indian Takeaway which is located at 44 High Street is authorised for the provision of late-night refreshment between the hours of 23:00 and 01:00. Friday to Saturday and between the hours of 23:00 and 00.30 on a Sunday. The Old Town Fish Bar, which is located at 46 High Street, is authorised for the provision of late-night refreshment between the hours of 23:00 and 04:00 Friday to Saturday and 23:00 to 02:00 on a Sunday.

#### 5 RESPONSIBLE AUTHORITIES

- 5.1 Representations have been made by two of the Responsible Authorities, the Local Planning Authority and Environmental Health.
- 5.2 The Principal Planning Officer and Development Manager for the Local Planning Authority has objected to this application on the basis that the restaurant is now closed, and the premises are currently operating as a hot food takeaway with delivery (Planning use class sui generis) without planning permission and are therefore in breach of the planning regulations. In summary, the proposed variation of the premises licence is not in accordance with the current lawful use of the property as a restaurant (Planning use class E) and is therefore considered unacceptable from a planning perspective.

  Moreover, as the use is unauthorised, the planning authority has not assessed its suitability with respect to its impact on nearby residential properties from a public nuisance perspective.
- 5.3 Environmental Health have concerns relating to the licensing objective prevention of public nuisance. To summarise, complaints have been received regarding the operations of the Taste of India adversely affecting an adjacent resident. The premises no longer operates as a restaurant, only as a takeaway with delivery staff accessing the premises from the rear. Delivery drivers park on the privately allocated parking spaces to the rear of the resident's home under their openable windows, with their engines running. The regular opening and closing of the metal gate caused continual disturbance. The Food business Operator has now secured the gate open whilst trading, however this still clanks when it is closed at the end of the night. The refuse bin is also placed outside the resident's openable window, prior to collection.

#### 6 INTERESTED PARTIES

- 6.1 Representations have been received from the landlord and tenant of 44a, a residential premises located adjacent to The Taste of India. These representations have been made under all four of the licensing objectives, though predominantly for the objective, 'Prevention of Public Nuisance'. To summarise, there is concern with regards to delivery vehicles parking underneath the windows of the property at 44a High Street. Drivers leave their engines running whilst they collect orders which subsequently cause noxious fumes to enter the property. The family residing at the property have young children and are unable to open their windows to increase ventilation. Rubbish bins are left in the private parking area underneath the windows of the property causing nuisance, with the smell of rotting food entering their property. Persistent use of the rear entrance of The Taste of India is also causing noise disturbance, the gate is left open whilst the business is operating and slams in the wind. There is also concern that the extended hours will lead to increased anti-social behaviour. Representations are attached at Appendix C.
- 6.2 The Licensing Officer has liaised with Environmental Health and the applicant to discuss all representations received. Additional conditions have been proposed to the applicant to address the concerns of all persons making representations. The applicant has agreed to voluntarily amend their application to include 4 additional conditions to the operating schedule on the premises licence. These are as follows:
  - Delivery vehicles shall not park in the private parking area to the rear of 48a High Street when collecting food orders for delivery.
  - All delivery drivers shall park in the small public car park in Primett Road which is at the rear of 48a High Street when collecting food orders for delivery.
  - The collection of food orders for delivery shall be from the front entrance of 48a High Street from 20:00hrs Sunday to Thursday and from 21:00hrs Friday to Saturday.
  - Waste receptacles shall not be placed within the area designated for private parking at the rear of 48a High Street.
- 6.3 The applicant has also agreed in an email dated 16<sup>th</sup> November 2023 that the restaurant will re-open in January 2024 as per the lawful use of the property.
- 6.4 The proposals made and subsequently agreed by the applicant to voluntarily amend their application, have been passed to those responsible authorities and other interested parties who have made representations. The Local Planning Authority and Environmental Health have both withdrawn their representations following the amendments made to this application by the applicant.

- 6.5 Environmental Health are happy with the agreed conditions for the premises licence and believe they address the issues raised by the resident of 44a High Street. Environmental Health have advised the premises licence holder, Mr Rahman about the issues with the rattling of the gate when in the closed position. Mr Rahman has advised that he will speak to his builder with regards to resolving the issue.
- 6.6 The Licensing Officer continues to liaise with the landlord and tenant of the residential property adjacent to the Taste of India with regards to their representations. These remain upheld upon the deadline for the publishing of this report.

17.4 In instances where the crime prevention objective is being undermined, revocation, even in the instance of this being a first review of the premises licence, or club premises certificate, will be given serious consideration.



It is understood the restaurant is now closed and the business is operating a delivery and takeaway service only. At the time of writing, no planning application has been received to regularise the breach in planning control.

Every single tenant we have had has complained about the loud noise from the gates when shutting and the way they dispose of their garbage with the waste bins left open against the side wall of the property and smells permeating from the rotting food.

This is particularly horrendous during the summer months as it also encourages maggots crawling and making their way through the open windows into the property.

Lately there has been further increase of noise from delivery personnel who leave vehicle engines raving while waiting to collect their orders despite the fact, that there is a notice stating they should not do so.

Customer and staff alike park right next to the wall of the property in order to ensure that their cars are not on the double yellow lines. Again despite the fact that there is free parking not very far from them which they can use and is easily accessible.

We have tried to resolve these issues several times in the past by speaking to the owner as well as the staff. We have found the owner to be extremely rude, abrupt, uncooperative and quite frankly intimidating whenever these interactions have taken place. In his absence when the staff have been approached they would simply shrug their shoulders or claim they are unable to speak English. We have in the past complained to Environmental Health Personnel (EHP) who have visited the property with us and actually seen the overflowing bins accompanied by photographic evidence. We have tried to involve the local councillor, Thomas Frankland who also has visited our property and has verbally agreed that our complaints are well founded. He assured us that he would be taking this up with EHP.

Previously all our tenants with exception of the present one, have been childless couples. They would complain to us, we would then take the next steps and based on the outcome ask the tenants

to monitor the situation/speak to the owner/report to EPH/record incidents. However as most were working full time and the fact that there were no children involved, the mater would eventually be placed on the back burner.

Our present tenant, quite rightly, is deeply affected by the current situation compared to previous ones. He worries about his young children

- are being obliged to breathe noxious fumes from the raving vehicles
- are young and vulnerable and being exposed to harmful microorganisms breeding in the open bins
- are having interrupted sleep during the nights because of the added traffic activity. This will
  no doubt become a bigger problem once they start nursery/school.

He too has tried to resolve the concerns with the owner of the Star of India. He too like us found him to be rude and aggressive.

We have looked at the four licensing objectives and have no doubt each of these apply to our representation. that Your representation must be relevant and refer to the application and what has been applied for, it must also relate and refer to one or more of the four licensing objectives which are as follows:

- 1. The prevention of crime and disorder:
  - The owner to all intents and purposes seems to be only concerned about his business interests. To date we have not seen any evidence that he is actually interested in what goes on outside the four walls of his premises. Increasing the business hours will increase incidents of social misconduct. Broken bottle pieces are frequently found as a result of customers who have flung these against the walls of the property or smashed them outside the paving slabs at the front.
- 2. The prevention of public nuisance

This is twofold: the first is related to point number one with inebriated customers leaving the premises late night and misbehaving on their way home. Secondly, the late hour will mean there are no patrolling traffic wardens encouraging more drivers to park wherever and however they like, ignore the signage of 'private parking' and park anywhere they please. In this case as close to the property as possible as it makes for the shortest distance they would need to walk.

- 3. The promotion of public safety:
  - Cars and mopeds are a source of hazard for the general public at the best of times; more so when the drivers are not entirely sober. A lot of residents mostly elderly use the through walkway to get to the High Street and an out of control or speeding vehicle would be a sure cause of concerns for public safety.
- 4. The protection of children from harm
  In the case of the present tenant the harm is not just physically caused by exhaust fumes,
  being exposed to harmful microorganisms, threat of being knocked down by vehicles but
  mental as well whereby the youngsters are undergoing sleep deprivation on a regular basis.

Referring to the undertakings being proposed by the owners of The Star of India TSOI) who have said that:

1. Delivery drivers shall switch off their engines whilst stationary and collecting orders for delivery. Complaints have been made about this and a notice gone up. The drivers comply for a few days and then revert back to their old ways. How will TSOI enforce this? What will be the consequences for the drivers who do not comply?

- 2. Delivery vehicle horns shall not be used at any time except in accordance with the Highway Code.
- 3. Notices shall be prominently displayed at the rear of the premises requesting staff to respect the needs of local residents and use the area quietly:

  There is already a notice on one of the lamp post at the rear. No idea how further notices are going to improve or alter the situation. Again the same query: How will TSOI enforce this? What will be the consequences for the drivers who do not comply? We hope they are not intending of putting a large luminous notice board on our rear wall in a similar fashion to the hinges of their gate that they have drilled illegally on our property wall.
- 4. We are also concerned that nowhere have they mentioned about the increased refuse the extended hours will create and how do they propose to dispose this. The present at the moment is bad enough and should their application be approved the situation will become unbearable. EPH have not to date resolved this neither has this been put forward as a prerequisite as far as we are concerned. When there is an establishment which clearly seems to be wholly impervious to concerns and complaints, allowing them to extend their hours is simply giving them carte blanche.
- 5. For almost eight years we have been trying to get some resolution. This hasn't happened. Instead we are now facing a proposal which, if approved, will place us in a very difficult position and through no fault of ours is going to make our present situation a lot worse

- 7) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- 13) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 11 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

- 1) Alcohol shall not be sold or supplied except during permitted hours. As shown in part 'M'
- 2) The above restrictions do not prohibit:
  - the consumption of the alcohol on the premises during the first twenty minutes after the above hours;




