# 2 MINUTES – Wednesday 4<sup>th</sup> April, 2007

It was **RESOLVED** that the Minutes of the meeting of the Council held on Wednesday 4<sup>th</sup> April, 2007, having been circulated, be taken as read, confirmed and signed by the Mayor as a correct record, subject to the following amendments:

## 3 APPOINTMENT OF MAYOR

The Mayor, Councillor S. Speller delivered his end of year speech in which he reflected on his term of office. He spoke about how enjoyable and successful the

He thanked all those who had contributed to his year in office and particularly mentioned Officers of the Council, Member Services and Councillor Sharon Taylor for their support during the year.

Councillor Sharon Taylor thanked Councillor Simon Speller for all his hard work during the year, which had helped to raise the profile of the Office of Mayor as well as his charities.

Councillor Taylor also requested that the Council's congratulations be forwarded to the players and management of Stevenage Borough Football Club for their FA Cup win and Councillor G. Clark agreed to do so.

Councillor Speller called for nominations for the Office of Mayor for 2007/08.

It was duly proposed and seconded that Councillor Graham Clark be nominated as Mayor for the 2007/08 Municipal Year. There being no other nominations, a vote was taken and it was RESOLVED that Councillor Graham Clark be elected as Mayor for the 2007/08 Municipal Year.
