SETTING THE AMOUNT OF COUNCIL TAX FOR THE COUNCIL'S AREA

- 1. That the following be approved:
 - a. the probable revenue estimates for the year 2007/08 amounting to £15,131,120 and the revenue estimates for 2008/09 amounting to £15,012,420;
 - b. the contribution from balances of £2,641,529 in 2007/08;
 - c. the contribution from balances totalling £2,064,690 in 2008/09.
- 2. That it be noted that at its meeting on 23rd January 2008 the Executive calculated the amount of 28,225.00 Band D equivalent properties as its council tax base for the year 2008/09 in accordance with Regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 made under Section 33(5) of the Local Government Finance Act 1992.
- 3. That the following amounts be now calculated by the Council for the year 2008/09 in accordance with Sections 32 to 36 of the Local Government Finance Act 1992:
 - a. £12,947,730 Being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)(a) to (e) of the Act, less the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)(a) to (c)
 - b. £7,775,078 Being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed non-domestic rates and revenue support grant
 - c. £51,508 Being the utilisation of the Council's share of the estimated surplus totalling £395,000 as calculated in accordance with Sections 97(3) and Section 98(4) of the Local Government Finance Act 1988

d. £181.44 Being the amount at 3a. above less the amounts at 3b. and 3c. above, all divided by the amount at 2. Above, calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its council tax for the year
