2 MINUTES - Wednesday 27th February, 2008

It was **RESOLVED** that the Minutes of the meeting of the Council held on Wednesday 27 February, 2008, having been circulated, be taken as read, confirmed and signed by the Mayor as a correct record.

3 APPOINTMENT OF MAYOR*

Before presenting his end of year address the Mayor paid tribute to former Mayor Alf Luhman and Tony Turner who had both recently passed away.

A number of Members spoke in tribute to both former councillors.

The meeting then observed a minute's silence in remembrance of Alf Luhman and Tony Turner

which he reflected on his term of office. He spoke about how enjoyable and successful the year had been and mentioned how pleased he was to serve the council and the town of Stevenage.

He thanked all those who had supported him and the Mayoress in their year in office, particularly the Mayor and Mayoress Designate (Councillor Patston and Deborah Patston), the Deputy Mayor and Mayoress (Councillor John Lloyd, CC and Councillor Mrs Joan Lloyd), the leader of the Council, Councillor Taylor, CC and the staff in Member's Services, particularly Tracey Frost.

Councillor Clark called for memebers' nominations for the Office of Mayor for 2008/09.

Councillor Taylor, CC, proposed Councillor Patston be nominated as Mayor for the 2008/09 Municipal Year and this was seconded by Councillor Speller. There being no other nominations, a vote was taken and it was **RESOLVED** that Councillor Patston be elected as Mayor for the 2008/09 Municipal Year.

Councillor Patston made the statutory declaration of acceptance of office.

The Mayor announced that his wife Deborah Patston would be Mayoress for 2008/09.

In his inaugural speech, Councillor Patston stated how proud he was to be elected into the office of Mayor of Stevenage.
