Article 1

Re-drafted to more clearly detail the objectives and general principles of the Constitution.

Redrafted to be less prescriptive, makes reference to Scrutiny Topic Groups rather than the various Panels. Detail of functions now included in Part 3 'Responsibility for Functions'

Article 7

General update. Details of the terms of reference of the various Executive bodies moved to Part 3 'Responsibility for Functions'.

Article 8

Revision brings together the former Articles 8, 9 and 10. Greater detail on the work of these bodies moved to incorporates the Part 3 'Responsibility for Functions'.

Article 9 (previously Article 11)

Now details the individual formal Joint working arrangements at Member level

Article 10 (Previously Article 12)

Factual changes and now less prescriptive

Article 11 (Previously Article 13)

Clarifies the types of decisions. Change to definition of 'Key Decisions' -

In 2001 the definition of a 'significant' decision included reference to expenditure or savings, exceeding £50,000 (revenue). It is recommended that this figure be raised to £75,000 in line with new Contract Standing Orders agreed earlier in 2008; and that it be clarified that such expenditure/savings have not been accounted for in the agreed Budget.

Concerning expenditure on the acquisition of goods, services or works – this has been simplified to exclude expenditure under £250,000. where provision has been made within the budget and are to be dealt in accordance with existing Council policy, contract standing orders and financial regulations.

Details have also been included of the specific provisions required for decision making by the Executive, Committees and Sub-Committees and Individual Councillors, and in the case of Key Decisions, individual officers.

Article 12 (Previously Article 14)

No change

Article 13 (Previously Article 15)

Now provides for the Chief Executive to authorise factual updates

Article 14 (Previously Article 16)

Now makes reference to the Council's website. This article has been revised to allow for all Members to be provided with a printed copy upon request rather than receive an updated hard copy automatically. The document will be available for public inspection and will be on the website.

PART 3 – RESPONSIBILITY FOR FUNCTIONS

No fundamental changes have been made although this section has been rewritten to allow the reader to more readily identify where decisions on individual matters are taken.

The terms of reference of the Executive, Executive bodies and all Committees are detailed here (rather than in Part 4 on the previous version), together with the allocation of functions to the Executive, collectively and individually

This section now includes a description of the role of the Leader and Executive Members

The Scheme of Delegation to Officers remains unchanged from that agreed in 2003.

'Ending a debate' – now renamed 'Closure Motions' and includes provision for any debate that has been adjourned, or any business remaining if the meeting is adjourned, to come back to the next ordinary or extraordinary meeting.
