1. APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were received from Councillors L Martin-Haugh, L Strange and V Warwick.

There were no declarations of interest.

2. MINUTES – WEDNESDAY 23 FEBRUARY 2011

Councillor Parker raised a concern that his comments on issues such as Budget Savings, Councillor Allowances, Town Twinning were not reflected within Minutes of the Main Debate item. The Mayor indicated that Council would note Councillor Parker's comments regarding the minutes.

It was **RESOLVED** that the Minutes of the meeting of the Council held on Wednesday 23 February 2011 be approved as a correct record and signed by the Mayor subject to an amendment to the second paragraph on page 3; The words 'Tory Group' should be replaced by 'Conservative Group'; the 'T' at the end of the paragraph should be deleted; and that the comments of Councillor Parker regarding the Minutes be noted.

3. APPOINTMENT OF MAYOR

The Mayor, Michael Downing, delivered his end of year speech. He spoke about the many engagements that he and the Mayoress had

attended and how quickly the year had passed. He mentioned a number of highlights during his tenure, especially meeting many local school children and raising a sum of £3,700 for his charities. He had met the fiancée and family of late Dr Karen Woo who died in Afghanistan which had been a moving experience. A meeting with Lech Walesa had also been very special and probably the most exciting moment was Stevenage beating Newcastle United in the F.A Cup.

Other Members congratulated him upon his year as Mayor and the service he had given to the Council as a serving Member.

He thanked all those who had supported him and the Mayoress in their year in office, particularly the staff in Members' Services for the help that they had given him.

As the Mayor had also stood down as a Councillor he took the opportunity to reflect upon the last 27 years and commented that the Council had faced very changing and challenging times. He ended by praising the work carried out by Council Officers who he considered were too often unjustly maligned.

The Mayor then called for nominations for the Office of Mayor for 2011/12.

Councillor S Taylor CC proposed Councillor C Latif as Mayor for the 2011/12 Municipal Year and this was seconded by Councillor R Henry.

There being no other nominations, a vote was taken and it was **RESOLVED** that Councillor C Latif be elected as Mayor for the 2011/12 Municipal Year.

Councillor J Mead, R Parker CC and G Snell requested that their vote in opposition to the above resolution be recorded in the Minutes as they considered that the Mayor should not be limited to members of the Majority Group.

Councillor Latif made the statutory declaration of acceptance of office.

The Mayor announced that her husband, Quazi Latif, would be the Mayor's consort for 2011/12.

In her inaugural speech, Councillor Latif stated how proud she was to be elected to the office of Mayor of Stevenage and paid tribute to the outgoing Mayor and Mayoress.

She stated that the Mayoral charities for the year would be:

- Age Concern
- Cancer Hair Care
- Stevenage Scouts
- Stevenage Community Trust

4. APPOINTMENT OF DEPUTY MAYOR

The Mayor then called for nominations for the office of Deputy Mayor.

It was duly proposed and seconded that Councillor John Lloyd CC, be appointed as Deputy Mayor for the 2011/12 Municipal Year.

Following the seconding of this nomination and there being no other nominations, a vote was taken and it was **RESOLVED** that Councillor John Lloyd CC be appointed as Deputy Mayor for the 2011/12 Municipal Year.

Councillor John Lloyd CC then made the statutory declaration of acceptance of office.

The Deputy Mayor thanked his proposer and seconder and announced that his wife, Mrs Joan Lloyd would be Deputy Mayoress for 2011/12.

5. BOROUGH COUNCIL ELECTIONS

Council considered a report that detailed the results of the Borough Council Elections that were held on 5th May 2011.

It was moved, seconded and **RESOLVED** that the results of the Stevenage Borough Council Elections 2011 be noted.

6. APPOINTMENT OF LEADER

The Mayor then called for nominations for the Leader of the Council.

Councillor J Gardner proposed Councillor S Taylor and this was seconded by Councillor L Chester.

There being no other nominations, a vote was taken and it was **RESOLVED** that Councillor S Taylor be appointed as Leader of the Council for the period 2011-2015.

The Leader thanked both the proposer and seconder for their kind words. She welcomed the Chair and Vice Chair of the Youth Council to the meeting and welcomed the recommendation to amend provisions in the Constitution which would allow questions from them to be submitted to Council. She informed the meeting that Councillor J Gardner would be the Deputy Leader for her term of office.

The Leader informed the meeting that the Executive was to compromise of the following Councillors with their portfolio responsibilities as stated.

Deputy Leader – Councillor J Gardner – Environment and Regeneration

Councillor S Batson MBE DL - Community, Health and Older People Councillor H Burrell – Children and Young People, Culture, Sport and Leisure Councillor R Henry – Safer and Stronger Communities Councillor Mrs J Lloyd – Resources Councillor R Raynor – Economy, Enterprise and Transport Councillor P Webb – Housing

Additionally, the Leader of the Council to have responsibility for Town Twinning, Media and Communications, Modernisation of Local Government – new political structures - and the Constitution, Public Consultation, Partnerships, Members' Services, including the Modern Member Programme and the Civic Suite.

The Leader stated that she did not propose to change the existing delegations to take executive decisions which are set out in the constitution; these would remain unchanged until further notice.

She explained that Section 236 of the Local Government and Public Involvement in Health Act 2007 permitted the Executive Leader to make arrangements for the discharge of executive functions by a Member in relation to that Member's ward. She stated that she was making arrangements for every member to control and spend a local community budget of £3,300 per annum – the spending of money in this context being an executive function. This sum may be used at the discretion of each individual member subject to the requirements of the law and the Council's Constitution and also to such procedures as may be devised by the Chief Executive and circulated to all Members. These budgets may be used only for the promotion or improvement of the economic, social or environmental well being of the Members' respective Wards.

7. CONSTITUTIONAL ISSUES

The Chief Executive advised the Council of a typographical error with recommendation 1 in the report relating to the composition of the Audit and Statement of Accounts Committees - it should read 6 for each Committee comprising 4 Majority Group and 2 Opposition Group.

Council considered a report that detailed various matters relating to the political management structure of the Council.

The recommendations in the report were moved and seconded with the amendment that the political composition of the Development and Scrutiny Committees was to be as set out on the yellow paper circulated around the chamber.

- 4. That it be noted that Ananda Hale, Allen Holland (Chair) and Emmanuel Mensah will continue to serve as Independent Members of the Standards Committee and Brian Mitchell as the Independent Non-Elected Member of the Audit Committee.
- 5. That the dates for Council meetings for the Municipal Year 2011/12 as shown at paragraph 4.19 of the report be approved and the draft dates for other meetings as detailed in appendix P to the report be noted.
- 6. That the Constitution be amended to include provisions for the Youth Council to submit questions to Council.
