Test of Opinion Survey

August 2011



Executive Summary

This report presents the results of a survey with tenants of Stevenage Borough Council. The survey aimed to find out tenants views on the future management of Council housing in the borough.

The survey involved telephone interviews, conducted by trained interviewers, of a random sample of 1,413 tenants from 8,115 tenanted addresses in the Borough. If grossed up to represent the total population of tenants, the results are accurate overall to within a sampling error of \pm 2.4% at the 95% confidence limit.

Test of Opinion 2011 Results

- 64% had read the leaflet which outlined the changes
- 67% felt they understood the changes proposed
- 42% who strongly or tend to support the proposal to bring management of council housing back into the council (rather than continue with Stevenage Homes)
- 41% of tenants had no feelings either way regarding the proposed change to bring management of council housing back into the council (rather than continue with Stevenage Homes)

The headline results are that the majority of those consulted **fully understood** the Council's proposal to bring housing management back in house. The telephone survey found 42% of tenants in support and 41% had no feelings either way.

For residents expressing support, there is a strong sense of things being better with the Council. Better services and value for money feature prominently as an advantage of the propose change.

There were no clear disadvantages mentioned by tenants regarding the change however those tenants who oppose the change gave a high level of advocacy for Stevenage Homes.



1. Introduction

Stevenage Borough Council commissioned Voluntas MRS, to conduct a survey with their tenants to explore their views on the future of Council housing in the borough.

This report details the findings from the tenants' survey.

1.1. Research aims and objectives

The aims of the survey were as follows:

- to establish whether tenants had read the information leaflet
- to outline to tenants the Council's proposals (where the leaflet had not yet been read)
- to establish the level of understanding for the changes being proposed by the Council
- to ascertain the level of support or opposition for the proposed changes
- to obtain tenants views on the advantages and disadvantages for the proposed changes

1.2. Survey method and accuracy of results

The survey involved trained interviewers conducting telephone interviews with tenants of the Stevenage Borough Council. A total of 1,413 interviews were completed split by two tenures:

In terms of the accuracy of the survey results, if grossed up to represent the views of the total population of Stevenage tenants, the results are accurate to within a sampling error of + 2.4% at the 95% confidence limit.

1.3. Conduct of the fieldwork

The survey fieldwork started on 4th August 2011 and was completed by 21st August 2011.

A copy of the survey is attached at appendix one. The survey was approved by the Stevenage Borough Council representatives and the Independent Tenant Adviser.



1.4. Notes to figures

Throughout this report, the figures show the results as percentages. Base numbers are shown where appropriate.


Percentages are rounded to the nearest whole number, and for this reason may not in all cases add exactly to 100. In some figures, totals do not add to 100% where more than one response was possible to a single question.



2. Survey findings

Respondents were asked about whether they had had an opportunity to read a leaflet from Stevenage Borough Council about proposed changes to the housing management service.

Please could you tell me if you have had an opportunity to read this leaflet which outlines the proposed changes?




Within the overall position, 72% of sheltered housing tenants and 60% of general needs tenants had read the leaflet.



Respondents were asked whether they felt they understood the changes that the Council is proposing to the way their home is managed.

How well do you feel you understand the changes Stevenage Borough Council is proposing to the way your home is managed?




64% of general needs tenants understood the changes fairly or very well whilst 72% sheltered housing tenants expressed the same views.



Respondents were asked whether they supported or opposed the proposed changes to the way their home is managed (direct management by the council rather than by Stevenage Homes).

Stevenage Borough Council's proposal is that your home would no longer be managed by Stevenage Homes but would be managed directly by the council.

To what extent do you support or oppose this proposal?



Within the overall position, 47% of sheltered housing tenants and 39% of general needs tenants either tended to support or strongly supported the proposal.



The results are presented in a "Word Cloud" which counts and sizes the word depending on how it is mentioned – the more time times the word is mentioned, the larger the word is presented in the Word Cloud.

Respondents were asked why they held the view, regarding the proposal.

Why do you have this view? (Tenants who tended to support or strongly supported the proposal)



There is a strong sense that tenants were happy with the Council before the transfer of management to Stevenage Homes and that saving money is important.



Why do you have this view? (Tenants who did not have a view either way)



The overriding theme is that there will be no difference and that the change will not have an effect on individual circumstances.

Why do you have this view?

(Tenants who tended to oppose or strongly opposed the proposal)



Stevenage Homes received a high level of advocacy from those tenants who oppose the proposals.



Respondents were asked what they considered as the main advantages of the proposed changes were.

What, if anything, do you consider to be the advantages of Stevenage Borough Council's proposal to change the way your home is managed?



Within main advantages, the following common themes emerged:

- Saving money
- Better services
- Council responsibility (to manage housing)



Respondents were asked what they considered as the main disadvantages of the proposed changes were.

What, if anything, do you consider to be the disadvantages of Stevenage Borough Council's proposal to change the way your home is managed?



There were no significant themes among the sample. Most tenants felt there were no disadvantages but where comments were made this typically covered:


- Drop in service standards

3. Demographics


The final section asked tenants about themselves.

Figure 3: Disability




Figure 4: Type of disability







Figure 5: Ethnic group
