DECISION NOTICE Urgent Decision Outside Budget & Policy Framework

Title: Review of the Treasury Management Strategy

Person Taking Decision: Cllr Sharon Taylor

This decision can not wait until the next meeting of the Council because due to the current volatility in the investment markets the council's investment portfolio would not be compliant with the minimum credit ratings specified.

Decision: That the Council's Treasury Management Strategy be amended as follows:

- That short term investments are made in the following order of preference:
 - 1. F1+ institutions
 - 2. Fully of part nationalised F1 institutions
 - 3. Other F1 institutions
- That officers review the applicability of money market funds during the current period of volatility in the investment market.
- That the Chair of the Audit Committee be advised of the changes proposed by the member steering group, and determine whether a review of the decisions taken is required.
- That the updated Treasury Management Strategy be submitted to Council at the earliest opportunity.
