1. APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were received from Councillors M Cherney-Craw, M Hearn and L Martin-Haugh. There were also apologies for lateness from Councillor S Batson MBE DL.

There were no declarations of interest.

2. MINUTES – WEDNESDAY 29 FEBRUARY 2012

It was **RESOLVED** that the Minutes of the meeting of the Council held on Wednesday 29 February 2012 be approved as a correct record and signed by the Mayor.

3. APPOINTMENT OF MAYOR

Before her end of year speech the Mayor 2011/2012, Councillor Carol Latif, informed Council of the sad death of Mr Jim Cockerton JP who had been the first Mayor of the Borough of Stevenage. The meeting stood for a minutes silence in his memory.

The Mayor then delivered her end of year speech. She spoke about the many engagements that she had attended and the visits she had made.

She said however that her favourite times had been those spent with charities in Stevenage.

The Mayor thanked officers for their help during the year and in particular thanked her husband Quazi for his support.

She concluded by wishing the incoming Mayor and Mayoress every success for the coming year.

Other Members congratulated her upon her year as Mayor and the service she had given to the Council.

The Mayor then called for nominations for the Office of Mayor for 2012/13.

Councillor S Taylor CC proposed Councillor J Lloyd CC as Mayor for the 2012/13 Municipal Year and this was seconded by Councillor J Gardner.

There being no other nominations, a vote was taken and it was **RESOLVED** that Councillor J Lloyd CC be elected as Mayor for the 2012/13 Municipal Year.

Note: Councillors J Mead, R Parker CC and G Snell requested that their abstention in the vote to the above resolution be recorded in the Minutes.

Councillor J Lloyd CC then made the statutory declaration of acceptance of office and stated that his wife, Councillor Mrs Joan Lloyd, would be his Mayoress.

In his inaugural speech, Councillor Lloyd CC stated how proud he was to be elected to the office of Mayor of Stevenage and paid tribute to the outgoing Mayor. He spoke of the highlights of the year to come, including the Queen's Diamond Jubilee, the Lighting of the Beacon and the Olympics.

The Mayor also said that he intended to hold several receptions in the Mayor's Parlour during the year so that he could say thank you on behalf of the Borough to the unsung heroes of the Town who supported local charities and organisations.

The Mayor concluded by stating that the Mayoral charities for the year would be:

- Combat Stress
- N.S.P.C.C.
- Royal British Legion

4. APPOINTMENT OF DEPUTY MAYOR

The Mayor then called for nominations for the office of Deputy Mayor.

Councillor A Webb proposed that Councillor Jack Pickersgill be appointed as Deputy Mayor for the 2012/13 Municipal Year and this was seconded by Councillor S Speller.

Following the seconding of this nomination and there being no other nominations, a vote was taken and it was **RESOLVED** that Councillor Jack Pickersgill be appointed as Deputy Mayor for the 2012/13 Municipal Year.

Councillor Pickersgill then made the statutory declaration of acceptance of office.

The Deputy Mayor thanked his proposer and seconder and announced that his wife, Mrs Margaret Davies-Pickersgill would be Deputy Mayoress for 2012/13.

5. BOROUGH COUNCIL ELECTIONS

In reply to comments concerning the count and the announcement of the results the Chief Executive confirmed that the arrangements put in place had met all necessary legal requirements.

 4.9 of the report and the subsequent amendments to the Council's Constitution be approved.
