# 6. 2013/2014 SCRUTINY WORKPLAN

Introducing the report, the Constitutional Manager noted the changes to the scrutiny arrangements agreed at Annual Council but reminded Members that items previously agreed by the former Development and Scrutiny Committee's could be included as scrutiny items:

Members were also advised of the following Policy Development items for consideration in 2013/2014:

Members were concerned that in view of the changes to the scrutiny structure, that actions from reviews previously undertaken were not lost, therefore Members requested that written updates on the recommendations of the previous reviews be provided for the Committee. They include the following:

- Cleanliness of the Neighbourhood Centre Shops
- Use of Garage Compounds for alternative parking
- Fixed Penalty Notices and Environmental Campaigns
- Inward Investment Opportunities
- Business Support and Training & Employment Opportunities for Young People

Members were concerned with the lack of information as regards the Council's Green Travel Plan and requested a written update on its progress. Members acknowledged the various car parking issues around town such as parking on grass verges, lack of parking bays and the painting of yellow lines and requested an Officer briefing.
