3. PRESENTATION – TREE AND HEDGE REVIEW

The Committee received a presentation from Lee Myers, Head of Environmental Services, Cristian Pinta, Arboriculture and Conservation Manager, Paul Seaby, Streetscene Manager and Julia Hill, Green Spaces Policy and Development Manager.

Issues around the Management and Maintenance of Trees, Shrub Beds and Hedges and the role of Green Space Volunteers within the Town were discussed.

In response to a question on how works were allocated, Members were informed that SBC had a Bio-Diversity Action plan and most of the tasks undertaken were updated regularly.

Members welcomed the possibility of pulling together of the various volunteer groups in different areas of the Council so that a common policy around volunteering could be developed.
