Following thorough consideration of the case by Members, Mr K and the Licensing Officers were invited back into the meeting to hear the Committee's decision.

It was **RESOLVED** that having considered all the evidence and oral representation, Mr K's Dual Licence be revoked with immediate effect.

Mr K was informed that he has the right to appeal to the Magistrates Court within 21 days.
