<p>4. REVIEW OF THE GRANT OF A DUAL DRIVER LICENCE – MR M</p>	
<p>It was RESOLVED that the Dual Driver’s licence be GRANTED subject to the following conditions:</p> <ul style="list-style-type: none"> • That the licensee shall only drive a licensed vehicle fitted with an in-car and out of car CCTV recording system (without sound). Stevenage Borough Council will assume responsibility as the Data Manager for the system. Access to the recorded images will be restricted to the Police and Stevenage Borough Council only. The CCTV system must be operational at all times that the vehicle is being used as a licensed private hire vehicle. Signage indicating that CCTV recording is taking place in the vehicle must be prominently displayed on any such licensed vehicle. • That CCTV recordings to be retained for 28 days. • Modification of the system to enable the recordings to be retained for 28 days in accordance with condition 2 to be made within 90 days. • Renewal of the licence will be reviewed after 12 months by the General Purposes Committee of Stevenage Borough Council. 	<p>O Adeoye Ext 2809</p>
