APPLICATION FOR VARIATION OF PREMISES LICENCE: THE PEARTREE

1 PURPOSE

To determine the application to vary the premises licence for The Peartree public house, Valley Way.

2 SUMMARY OF APPLICATION

2.1 Type of Licence applied for

An application was received from Camelot Inns & Taverns Ltd to vary a premises licence under section 34 of the Licensing Act 2003 (see appendix 1). The Licensing Authority accepted the application on 2 August 2005.

2.2 Summary of application

The Peartree is located in Valley Way, Stevenage (see appendix 2 for premises plan and appendix 3 for location map).

The premises is a Public House with a Premises Licence. That Premises Licence was a conversion of the Justices Licence and gave no permission for entertainments.

The variation application is to:

- Increase the hours for sale and supply of alcohol by:
 - Until 23:30hrs Sunday Thursday (closing half an hour later)
 - Until midnight Friday Saturday (closing half an hour later)
 - An additional 30 minutes on the Friday, Saturday and Sunday of Bank Holiday weekends, Christmas Eve and Boxing Day (closing half an hour later);
- To permit regulated entertainment until 23:30hrs Sunday Thursday, midnight Friday and Saturday, on New Years Eve/New Years Day until 01:00hrs;

- Regulated entertainment consists of
 - ≻ Film
 - ➢ Live music
 - Recorded music
 - > Anything of a similar description
 - > Entertainment facilities for making music
 - Entertainment facilities for dancing;
- Permit late night refreshment in line with opening hours;

3 DETAILS OF THE PROPOSED VARIATION

These are described in the Operating Schedule. The table below summarises differences where they increase activities and/or hours:

5 PROMOTION OF LICENSING OBJECTIVES

The representations received relate to the objectives of the Prevention of Crime and Disorder and the Prevention of Public Nuisance. The operating schedule submitted by the applicant shows that those licensing objectives will be met as follows:

Please note that the operating schedule must be converted into conditions on the premises licence should the variation be granted.

5.1 THE PREVENTION OF CRIME AND DISORDER

5.1.1 Since acquiring these premises in December 2005 no issues relevant to prevention of crime and disorder have been raised. Our manager will attend bar watch meetings and seek to be involved with local police giving assistance as required.

5.2 THE PREVENTION PUBLIC NUISANCE

- 5.2.1 The manager is responsible for going outside the pub at 30 minute intervals during live music/karaoke etc to ensure no noise is audible beyond the boundary of the pub.
- 5.2.2 Action should be taken as urgently as possible to reduce any excessive noise levels.
- 5.2.3 Live music/karaoke etc shall finish by 23:00hrs Monday Thursday and midnight Fridays and Saturdays.

Licensing Officer's Comments: except for New Years Eve/Day, when the end time is 01:00hrs.

5.2.4 All windows and doors shall remain closed (doors returning to close position) at all times when musical entertainments are taking place.

- 5.2.5 Jukebox music must not be audible outside the pub at any time.
- 5.2.6 Signs requesting people to leave quietly and respect neighbours will be positioned by main exit. The manager is to use their best endeavours to obtain the cooperation of their patrons in this respect.
- 5.2.7 The fire escape doors in the Public Bar of the pub shall be kept closed and not used for any other purpose than a means of escape. They must not be held open or used to supplement the ventilation of the bar.
- 5.2.8 There must be no service or consumption of any drinks on the front terrace or rear beer garden at any time after 22:30hrs.
- 5.2.9 There must be no external disposal of trade waste between 23:00hrs and 07:30hrs.
- 5.2.10 When entertainments are taking place the level of noise emitted from the premises shall not be sufficient to cause a statutory nuisance. After 23:00hrs noise emitted from the premises shall be inaudible at any residential premises.

6 **RESPONSIBLE AUTHORITIES**

No representations have been received from the Police, Environmental Health, Fire and Rescue Service, Trading Standards, Child Protection or Planning.

7 INTERESTED PARTIES

Representations expressing concerns about the application were received via a petition. The 11 addresses below were included on that petition, and their representations are attached as appendix 3. All live within 100 metres of the premises.

In addition a petition was received from interested parties in positive support of the application. This is attached as appendix 4. The Committee is advised that the petition was of 47 addresses, but only one could be counted as relevant under the Act. This was because the last 2 pages of the petition had no explanation of what the petitioners were signing for, and only one address on the first page was in the vicinity of the premises.
