| To prevent crime and disorder | Yes | <p>Please refer to the analysis report (attached), which indicates number of incidents and offences that have occurred at, or directly outside Liquid & Envy between 01/01/2007 and 18/06/2007, associated with crime and disorder.</p> <p>There have been a total of 231 offences on Kings Way between the above dates, of which 79 are directly linked to Liquid & Envy, which is a rate of 34.1%. This is a considerably high percentage rate for these premises over a 5 ½ month period.</p> <p>The report demonstrates that the majority of offences at Liquid & Envy have taken place from 11pm on a Saturday through to 2am on a Sunday morning, with a significant increase at 1am.</p> <p>Please also refer to the incident breakdown (attached) for the 5 ½ months (January 2007 to June 2007), which highlights significant incidents of concern.</p> <p>There are concerns with regard to Liquid & Envy's proposed application of an extension as follows:</p> <ul style="list-style-type: none"> • Alcohol hours on a Sunday from 1.30am to 2.30am and • Closing hours on a Sunday from 2am to 3am. <p>Concerns are that the continued pattern of crime and disorder offences will continue if the premises are allowed to remain open beyond 2am on a Sunday. More crimes are consistently recorded in and around these premises than any other premises on the Leisure Park. The highest offence being possession of controlled drugs (cocaine). There is also a significant increase in 'other wounding' after 1am. At this present time these are the only premises on the Leisure Park that close at 3.30am between Monday & Saturday and the only one until recently that was open until 2am on a Sunday.</p> <p>At this present time the Leisure Park accommodate a taxi marshalling system on a Friday & Saturday night, however there is none on a Sunday night. On average there are 15-20 taxis on a Sunday. There are concerns that if these premises were permitted to be granted to extend hours on the Sunday then how would these premises make provisions for their clientele to disperse from the Leisure Park as quickly as possible, in order to ensure public safety and to prevent public nuisance.</p> <p>These premises are currently highlighted fortnightly as a number 1 hotspot premises due to the level of crime and disorder mainly on a Friday, Saturday and early hours of Sunday mornings. It can be confirmed that the premises have been on an action plan since the end of December 2006 to the present time, where the premises have worked</p> |

Incidents & Offences 01/01/2007 to 18/06/2007 Liquid and Envy, Stevenage Leisure Park


(All figures are taken from NMIS and should be treated with care due to the differing crime and incident class recordings from that of CIS/OASIS. Figures are as accurate as possible but there may be occasions where the pub may not be specifically mentioned, but an incident/offence may have occurred here or a street offence may have occurred that does not fall into a specific address. For this reason, the area surrounding the Leisure Park has been included.

The following document shows the number of incidents and offences that have occurred at, or directly outside Liquid and Envy between the 01/01/2007 and 18/06/2007. Incidents/offences include Criminal Damage, Common Assault, Fights, Drunken Behaviour, Anti Social Behaviour and Disturbance.

Offences

There have been a total of 231 offences on Kings Way between the aforementioned dates. Of these 34.1% (n=79) were directly linked by premises name to Liquid Envy.

Graph to show Offences between 01/01/2007 and 01/06/2007





The graph above shows offences by week. Offences have remained relatively stable with peaks identified at Liquid Envy during the Easter period and the May bank holiday weekends when more people are expected to be socialising at this location. Offences at the Leisure Park and Town Centre would appear to have staid relatively stable since Operation Sword was implemented in July 2005. This provides visible and positive policing by reducing and confronting Crime and Disorder at the Leisure Park.

Whilst this has assisted in reducing the number of offences at the Leisure Park it is important resources are not stretched when premises close.

The graphs below show the temporal analysis of offences at Liquid Envy. It is interesting to note that peaks are identified towards the end of the night when premises are beginning to quieten down and people vacate the premises. There is a significant peak between 01:00 and 02:00 with a slightly smaller peak between the hours of 23:00 and midnight. The peak days show very little significance however Saturdays and Sundays are slightly higher which can be expected due to this being some of the peak days for Liquid Envy.

The highest offence type across the Leisure Park was Other Wounding with 66 offences, 16 of which were directly linked to Liquid Envy. Temporal analysis revealed that the peak time for these offences were between the hours of midnight and 03:00 with 3 degrees of significance. Peak days were Sundays. It must be remembered that the majority of these were from close of business on a Saturday night.



Incidents

There have been a total of 49 incidents of anti social behaviour in the aforementioned area between 01/01/2007 and 18/06/2007. 18.4% (9) of which were recorded as occurring on Liquid Envy's property. However, Incident levels have remained low at Liquid Envy since the start of the year. The success of Operation Sword evident again with such low levels of incidents recorded at the Leisure Park.

The following table shows the number and type of incidents that occurred at Liquid Envy compared with the Leisure Park it's self. 7 of the 8 Rowdy/Nuisance incidents occurred after midnight.

The graphs below show the temporal analysis of incidents at Liquid Envy since the start of the year. The peak day for incidents although the significance is low identifies Mondays, when analysing in more detail this would appear to be in the early hours as the premises is closing after Sundays business. In addition Time analysis suggested more incidents occurred between midnight and 03:00. (it must be remembered a small sample of 9 incidents has been used).

Summary

- 34.1% of all offences at Kings Way between 01/01/2007 and 01/06/2007 were directly linked to Liquid Envy
- Offence levels peaked slightly at key times such as Bank Holidays and Easter Holidays.
- Offences increased on Saturdays and Sundays in the early hours leading to the close of business.
- The key offence types at the location were Possession of Drugs followed by Other Wounding.
- Levels of Anti Social Behaviour (non-crimed) remain low with only nine incidents reported.
- The majority of these incidents were reported after midnight.

| Sunday 10/06/2007 | 00:30hrs | 1 arrested for S5 POA. Offender continued to hang around in the area, repeatedly being aggressive, threatening and abusive towards IP. Was given numerous warnings, the offender then went for IP who had to push him away and when the offender came at him again the officer deployed his PAVA spray and arrested. Offender was intoxicated. |
| Saturday 09/06/2007 | 23:55hrs | 1 issued with FPN for 5 POA. Offender was ejected from Liquid. Whilst being ejected he was seen on CCTV shouting at bouncers and making rude hand gestures, he was also swearing. |
| Saturday 09/06/2007 | 23:37hrs | Call from officers at the scene stating fight and request for more units. Male bottled in head, he sustained head injury to the centre of the forehead. 1 arrested for POA. Offender was with a group of friends inside club, where an altercation which continued into foyer area. Offender used disorderly conduct whilst exiting the club engaged the bouncers in scuffle and was detained on the floor by bouncers. Offender was under the influence of alcohol. |
| Saturday 09/06/2007 | 23:05hrs | 1 arrested for possession of class A - cocaine. Security staff were conducting a routine check of the male toilets in the club where they have seen the offender locked in a cubicle on his own holding a clear plastic bag containing white powder. |
| Friday 08/06/2007 | 23:45hrs | 1 arrested for possession of controlled class A drug - cocaine: Security Staff conducted a routine check of the gents toilets where they saw the offender in possession of a small piece of folded paper. On inspection the paper contained what is believed to be powder cocaine. Offender admitted the offence to staff at the time. |
| Friday 03/06/2007 | 03:19hrs | 1 arrested for drink drive. Report from officers at the scene stating drinker driver outside train station. Offender was seen driving when the vehicle was seen swerving. Offender was unsteady on his feet, smelt strongly of intoxicated liquor. Offender stated he had his last drink at Liquid Nightclub and had consumed 4 pints of lager. |
| Friday 01/06/2007 | 23:40hrs | 1 arrested for possession of controlled class A drug - cocaine. Offender seen by security staff in the male toilets acting suspiciously, on leaving the toilets offender searched and a small clear plastic bag containing white powder was found, this powder believed to be cocaine. |
| Sunday 27/05/2007 | 01:36hrs | 1 arrested for possession of controlled class A drug - cocaine. Member of doorstaff detained a person in possession of unknown drug. Offender was found in toilet cubicle by security holding a wrap. On police arrival male was seen being restrained. Offender was very intoxicated. |

Following a fight outside Liquid the offender was identified as responsible for assaulting 2 males causing them injuries amounting to ABH.Offender and IP entered into an altercation during which offender hit the IP to his left eye using a bottle. Offender had consumed alcohol. |
| Saturday 26/05/2007 | 01:55hrs | 1 arrested for driving whilst unfit. Officers on the Leisure Pk alerted by leisure park security staff to a vehicle which had nearly driven into the plastic barrier. Officers spoke to the driver who was slurring his words. Offender unsteady on his feet when asked to get out of his vehicle and smelt strongly of alcohol. Offender stated he had consumed his last drink in Envy Nightclub. He stated he had consumed 2 small bottles of beer and 1 pint of beer prior to the offence. He also stated he had consumed 1 beer at home before he came out. |
| Sunday 20/05/2007 | 00:56hrs | 1 arrested for ABH. An altercation had occurred in Liquid, during which the offender hit IP round the head with a bottle causing injury and much blood loss. Offender was identified by IP and several witnesses and detained by door staff. |
| Sunday 13/05/2007 | 01:12hrs | Officer at the scene reporting a fight outside Liquid. 2 groups of people having a bit of an altercation, but all calm now. |
| Saturday 12/05/2007 | 00:14hrs | Officer reporting that another officer outside Liquid & Envy, assistance required. 2 arrested for S5 POA. Offender 1: Ejected from club following an altercation within the club. Was being abusive towards door staff shouting and swearing and inciting them to fight. Offender moved away by police but threatened to break officers legs launching into a torrent of abuse. Offender 2: In company with above offender was verbally abusive towards police after being ejected from Liquid. Both offender and his cousin were squaring up to single officer with clenched fists and continually swearing towards officer and door staff. |
| Saturday 05/05/2007 | 01:43hrs | 1 arrested for criminal damage. Offender entered female toilet to use the straighteners at the club. Staff entered the toilet where they saw the female smashing the straighteners on a hand drier. Offender was under the influence of alcohol. |
| Friday 04/05/2007 | 23:55hrs | 1 arrested for possession of controlled class A drug - cocaine. Offender found in premises by security in possession of a small clear plastic bag containing a white substance. Offender admitted to this being cocaine. Offender was under the influence of alcohol. |
| Sunday 29/04/2007 | 01:15hrs | Assistance requested by officers to Liquid. 1 arrested for ABH on staff & Assault on Police. 2nd person arrested for common assault. Large group of males ejected from Liquid. Offender 1: Whilst in an intoxicated state he was inside the club where IP was working as security staff at which point IP approached offender and asked him to leave the club. Offender refused resulting in a struggle between the 2 and the offender striking IP in the face with his hands, resulting in IP having pain and discomfort and a red mark above his right eye. Offender was removed from the club where officers attempted to detain him, however he resisted which resulted in a struggle to the floor and the offender kicking out and hitting officer's hand causing pain and discomfort. Offender was under the influence of alcohol. Offender stated he had consumed his last drink at Liquid and that he had consumed 8+ alco pop drinks prior to offence. Offender 2: Jumped on IP's back in attempt to free an associate of his who was being detained by doorman. Offender detained and arrested by police. Offender was under the influence of alcohol. |

| Saturday 28/04/2007 | 02:12hrs | 1 arrested for S5 POA. Police were speaking with door staff at Liquid when offender was evicted from premises. Offender stood blocking the doorway staring at door staff trying to provoke an incident. He was asked by Police to move away from the doorway, but he refused stating that he was looking for his coat ticket, he has made no attempt to find his coat ticket and has been asked again to move away from the door and return when he has found it, he has replied by swearing. He was warned under S5 but continued with his abusive swearing. |
| Friday 27/04/2007 | 23:24hrs | 1 arrested for possession of class A - cocaine. Whilst completing searches of the toilet area within the nightclub, staff located the offender in toilet cubicle in possession of a paper wrap containing white powder substance. Offender stated that he bought it off a bloke in the club. He stated he had his last drink at Liquid and that he consumed a couple of pints of lager and a couple of shots in licensed premises. He also stated he had consumed approx 5 pints of lager and a couple of shots at home/friends prior to going out. |
| Sunday 22/04/2007 | 01:07hrs | 1 arrested for ABH. Verbal altercation took place between a group of girls, where offender walked up to IP and hit her to side of face near right eye causing injuries. Was then detained by security. |
| Sunday 22/04/2007 | 01:01hrs | 1 arrested for possession of controlled class A - cocaine. Offender found to have in possession a white substance which he admitted was cocaine and therefore arrested. He stated he had his last drink at Liquid and had consumed lots prior to the offence. The incident he was involved in started inside Liquid. |
| Saturday 21/04/2007 | 02:36hrs | Ambulance requested to Liquid due to male with head injury. 1 arrested for ABH. IP was punched in the head causing injury. Offender detained outside the premises by door staff and police informed. IP was extremely intoxicated and was conveyed to Lister Hospital by ambo. |
| Friday 20/04/2007 | 22:30hrs | 1 arrested possession of controlled class A - cocaine. Offender found in the toilet of the club with a small see through bag containing 6 small white tablets. Offender stated he had consumed his last drink at Yates, The Plaza, Town Square, Stevenage. He stated he had consumed 2 pints of Guinness and 2 G&Ts in licensed premises. Incident he was involved in started in Liquid. |
| Sunday 15/04/2007 | 05:13hrs | Report from officers stating male trying to break a window at Cineworld with a bin. 1 arrested for S5 POA, no damage caused. Offender used foul abusive language towards officers and then attempted to assault Officers. Offender was heavily intoxicated at the time of the offence. Offender stated he had his last drink in Liquid and that he had consumed 6 pints in licensed premises prior to the offence. |
| Sunday 15/04/2007 | 01:25hrs | 1 arrested for Affray, ABH & Assault on Police. Officers called to a fight outside McDonalds. Officers saw a male on the floor bleeding from the head, the offender was identified and arrested. Offender was identified as being part of a group that had been involved in an altercation with IP outside Liquid short time prior. Offender stated he had his last drink at Liquid and had consumed 8 pints of stella in licensed premises prior to the offence. The incident he was involved in started in Liquid. |
| Saturday 14/04/2007 | 01:05hrs | 1 arrested for S5 POA. Offender became verbally abusive and aggressive and began shouting and swearing in public. Offender was under the influence of alcohol - unsteady on his feet, and his eyes were glazed. Offender was repeatedly warned about his behaviour but continued and was arrested. Offender was extremely intoxicated upon being evicted from Liquid for squaring up to bouncers and his aggressive behaviour and when officers started talking to the male he became abusive and aggressive. |

| 09/04/2007 | 0030hrs | IP reporting on 9/4/07 at 1954hrs that he was assaulted by bouncers last night, he has visible injuries. Incident took place at Liquid, crimed ABH. IP was in the club and was approached by bouncer, bouncer twisted IP's right arm behind his back and man handled him to a fire exit. IP struggled and the next thing IP can remember is being in a corridor next to the fire exit surrounded by 6 male bouncers. He was forced to the ground and told to stop struggling which he did. He was then stamped on his neck and could not breathe. IP was then seen by a female bouncer who intervened and the male bouncers then threw IP out through the fire exit. |
| Monday 02/04/2007 | 01:55hrs | Report from IP stating that he was assaulted tonight in the club. IP attended club with friends, upon going to leave, the IP's friend was pushed and head butted. IP has intervened to break up fight and offender has punched IP to the eye causing no visible injuries. Bouncers have intervened and escorted IP and friends from club. Crimed as common assault. |
| Monday 02/04/2007 | 01:15hrs | Report from IP stating he was assaulted at Liquid earlier tonight. IP attended club with friends, upon going to leave the IP has been pushed by offenders and head butted to the mouth causing no visible injuries. Bouncers have intervened and escorted the IP from the club. Crime as common assault. |
| Sunday 01/04/2007 | 02:27hrs | 1 arrested for possession of controlled drugs class A - Cocaine. Door staff found offender in the toilets with small bag of controlled substance. Offender admitted it was cocaine. |
| Saturday 31/03/2007 | 04:08hrs | Report from member of staff at Ibis Hotel, Danestrete, Stevenage, stating fight in progress. Fight between a male and a female. Male damaged hotel door. Offender stated he had his last drink at Liquid & Envy. Unsure as to how much alcohol consumed in licensed premises, but a lot. Incident he was involved in started away from the premises. |
| Saturday 31/03/2007 | 02:16hrs | 1 arrested for Possession of Controlled Class A Drug - Cocaine. Offender was caught by security at Liquid in the toilets. Offender was under the influence of alcohol. |
| Sunday 25/03/2007 | 02:45hrs | Officers at the scene requested an ambulance due to male with suspected broken nose. 2 x ABH. IP was walking towards the toilets, when he was pushed from behind by the offender and punched twice in the face. Offender(s) then made off on foot. |
| Thursday 24/03/2007 | 01:44hrs | 1 arrested for possession of controlled drugs class A - cocaine. Security staff at Liquid were on routine toilet checks, when offender seen exiting toilet cubicle with a white powder residue on his nose. Offender stated he had his last drink at Liquid and that he had consumed 6-7 pints of lager in licensed premises prior to the offence. The incident he was involved in started in Liquid. |
| Thursday 24/03/2007 | 00:05hrs | 1 arrested for possession of controlled class A drugs - Cocaine. Offender was located in the toilets of the nightclub with a wrap of white powder that he stated was cocaine. Offender was under the influence of alcohol. Offender stated he had his last drink at Liquid and had consumed 3 double vodka and red bulls in licensed premises prior to the offence. Incident involved in started in Liquid. |
| Sunday 18/03/2007 | 01:34hrs | 1 arrested for possession of controlled class A drugs - Cocaine. Offender was detained by door staff outside Liquid, who informed Police that they had grounds to believe the male was in possession of a drug. Search was conducted and drug found. Offender stated that he had his last drink at Envy and that he had consumed 10-12 pints in licensed premises prior to the offence. The incident he was involved in started in Envy nightclub. |

| Saturday 10/03/2007 | 22:37hrs | 1 arrested for possession of controlled class A drug - speed. Offender caught by door staff with drugs in the toilets. |
| Sunday 11/03/2007 | 01:53hrs | 1 arrested for possession fo controlled class A drugs - cocaine. Offender was in the toilets at the nightclub and was seen by security guard taking drugs. Offender was also under the influence of alcohol. Offender stated he had his last drink at Liquid. Unknown how much alcohol consumed in licensed premises as offender did not state. He stated he had consumed half a bottle of vodka at home/friends prior to going out. The incident he was involved in started inside Liquid. |
| Sunday 11/03/2007 | 02:58hrs | 1 arrested for sexual assault at Liquid & Envy. IP was standing near to a bar in the nightclub when offender reached under her long top and from behind between her legs and stroked her. IP turned around confronted the offender who was under the influence of alcohol. Offender stated he arrived at Liquid at around 2300hrs, whilst at the club they remained in one area for most of the evening. He stated that he had consumed 7 pints of stella throughout the evening & was being rowdy with his friends. Offender arrested outside Liquid. He stated he had his last drink at Liquid. |
| Sunday 04/03/2007 | Between 0100hrs & 0115hrs | Whilst in the club IP turned around and as he did so he was hit by the offender in the face with an unknown object. Offender was intoxicated at the time of the offence. No statements taken as both witness and IP too intoxicated. From the club the assault could be seen on the cctv tape and the offender can then be seen being escorted from the premises by the door staff. Offender not arrested. Crimed ABH. |
| Thursday 22/02/2007 | 02:49hrs | Call received from ambulance stating they have a female on route to hospital from outside KFC, Leisure Park, Stevenage with a head injury. Crimed ABH - IP has been inside the club, 2 unknown males have been having a verbal altercation which has turned more violent and one of the males has tried to punch the other male, but has missed and selectively hit the IP. |
| Thursday 22/02/2007 | 01:44hrs | Call from site security at the Leisure Park stating male being restrained outside, need assistance, one male being detained but has friends in the area, group gathering may be an allegation of criminal damage as he has been kicking the glass front doors. Male ejected from Envy had been throwing punches inside the club at unknown person. Staff took him out and he tried to get back in, when security stood in his way he started kicking off.
