ANNEX 1 - MANDATORY CONDITIONS

- 1) No supply of alcohol may be made under this licence
 - a) at a time when there is no designated premises supervisor in respect of it, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2) Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

- 1) The premises shall have two outside and three inside CCTV cameras which shall record images which will be retained in unedited form for up to 7 days and which shall be made available for any Responsible Authority on request.
- 2) Notices will be clearly displayed in the shop stating that no alcohol will be served to any person under the age of 18 years old.
- 3) A notice shall be displayed requesting that customers respect the rights of local residents by not causing noise or nuisance outside of the premises.
- 4) The Challenge 21 Scheme will operate. The only accepted documents for proof of age will be by way of a valid passport or driving licence.
- 5) A refusals book shall be kept and shall be made available for inspection on request by officers from the Police, Trading Standards or the Licensing Authority.
