















Petition to prevent Martin McColl Newsagent from the Sale of Alcohol

There is already an existing pub called St Nicholas in the area and Nelsons Supermarket selling alcohol to the local community. It will lead to unhealthy competition and have a negative impact these long-term established local businesses to survive during these difficult economic times whilst also encouraging a culture of late night drinking and therefore the potential for anti-social behaviour in the community affecting the safety of local residents.
