Consideration of this matter cannot wait until the next meeting of the Executive on 12 February as the Local Government Finance Act 2012 requires the tax base to be approved by 31 January 2014.

A final report could not be presented to the January Executive as technical guidance was required from the Department for Communities and Local Government, which was delayed and received on the 17 January 2014.

- 2. That the supporting NNDR1 return (Appendix A) is approved.
 - 3. That the amount to be retained by Stevenage BC under the business rates retention scheme be £1,754,238 for 2014/15 (net of the tariff and including Section 31 Grant).
- 4. That Members note the decision taken by the Chief Finance Officer to revoke the request for the formation of the Hertfordshire Business Rates Pool in 2014/15 from the DCLG (via the County Council).
