### Background

**The Allocations Policy** 

- Required by law
- Outlines the process for applying for social housing
- Makes best use of stock
- Maximizes access and choice for applicants





### Aims of the review

- Respond to increasing demand for not enough homes
- Fair and transparent for customers
- Help those in greatest need
- Meet legislative changes e.g.
  Homelessness Reduction Act, Domestic Abuse, Armed Forces Covenant

#### Proposed change one

"Do you agree that we should only accept applicants onto the Housing Register if they have a housing need?"

Consultation - Agree – 69% Community Select Committee – Agree

Applied to new policy as a qualification rule



### **Proposed change two**

"Do you agree that those with sufficient savings or income should be disqualified from applying for social housing?"

Consultation Agree – 63% *Community Select Committee – Agreed to investigate* further

### **Proposed change four**

"Do you agree that the number of bands that applicants can be placed into should be reduced?"

Consultation Agree – 78%

Community Select Committee – Agreed to make easier for applicants. Suggested Numbers for Bands

Applied to new policy - Band 1, 2 and 3



### **Proposed change five**

"Do you agree that applicants who haven't placed a bid in 12 months should be removed from the register?"

Consultation Agree – 75%

Community Select Committee – agreed in principle with communication to applicants about how to bid

Applied to new policy Officers to communicate bidding





### **Proposed change six**

"Do you agree that we should let homes based on housing need only, removing the sharing between bands?"

#### Removing "quota"

Consultation Agree – 75%

Community Select Committee – Agree

Applied to new policy



Some direct allocation needed for aids and adaptations, temporary accommodation or leaving home for an emergency



#### Proposed change seven

"Do you agree that the bedroom standard should be changed to allow for more household members to share, without requiring their own bedroom?"

#### Increasing age to 21 for sharing from 16

Consultation Agree – 56% Community Select Committee – Did not agree with age

Changes to new policy:



- Bedroom standard changed to age 18 for same sex
- 2 bed need not able to bid on 3 bedroom properties



### **Additional question**

*Do we want to give additional priority to Foster Carers?* 

Community Select Committee – did not agree

### **Other Proposed Changes**

Page 27

- Care leavers able to bid on 1-bedroom properties and higher priority – increase chances of securing
- Homeless Prevention Duty priority given if families can stay with friends or families for additional time
- Housing Need adults without children with no other housing need unable to join the register
- Statutory Homeless Duty Discretion applied and must qualify otherwise – such as residential local connection
- **Owed Relief Duty** same priority as Main Duty which will reduce strain on temporary accommodation
