#### 1 APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were submitted on behalf of Councillors Doug Bainbridge, Rob Broom, Jody Hanafin, Liz Harrington, Graham Lawrence, Andy McGuinness and Lin Martin-Haugh.

There were no declarations of interest.

#### 2 APPOINTMENT OF VICE-CHAIR

It was moved, seconded and **RESOLVED** that Councillor Loraine Rossati be elected Vice-Chair of the Licensing Committee for the Municipal year 2021/22.

#### 3 LICENSING APPLICATIONS - PROCEDURE

The procedure for the Hearing of Licensing Applications was noted.

#### 4 APPLICATION FOR A NEW PREMISES LICENCE - CITY TREE LTD, STATION SHOP, UNIT 1 LYTTON WAY, STEVENAGE

The Chair welcomed all parties to the meeting and all those present introduced themselves. All parties present confirmed they had received a copy of the procedure note for the meeting.

The Licensing Officer, Stevenage Borough Council advised that the issue for consideration by the Committee was an application for a new Premises Licence for City Tree Ltd, Station Shop, Unit 1 Lytton Way. He advised that the British Transport Police and Hertfordshire Police had made representations objecting to the application.

The application was for the sale of alcohol off the premises from 08:00 to 23:00 Monday to Saturday inclusive and 10:00am to 22:30pm on Sunday.

The Chair thanked the Licensing Officer and invited representations from the Objectors to the Licence.

Police Inspector Kevin Buck from the British Transport Police and Sergeant Chris Adshead from the Community Safety Unit of Hertfordshire Police addressed the Committee and explained the reasons for their objection to the new Licence.

The Police representatives stressed that they were not objecting to the premises or to the applicant as a business owner but purely to the sale of alcohol at the premises. Their objections related to the high number of incidents, particularly suicides and attempted suicides at the railway station and the impact on all those involved including station staff as well as the general public.

The Committee was also advised of the rise in anti-social behaviour issues including aggressive begging at the station which in the opinion of the Police would potentially be exacerbated by the sale of alcohol at the station and in their view, the availability of alcohol in such proximity to the railway would increase the risk to vulnerable people and fuel any alcohol addiction.

The Chair thanked both Officers and invited Mr Bhatt, the Applicant to address the Committee.

Mr Bhatt informed the Committee of his experience and record of running a successful Stevenage Town Centre business. He spoke about his willingness to work with the Authorities to try to alleviate the concerns of the Police. The Committee were also advised that Mr Bhatt had proposed to train his staff members who would be working at the premises, in mental health awareness as well as agreeing to limit the range and reduce the hours of sale of alcohol and also to ensure alcohol was kept behind the counter.

After each party had been given the opportunity to sum up their case, the Chair asked the applicant, objectors and Licensing Officers to leave the meeting whilst the Committee considered the evidence presented.

During their deliberations, Members questioned the access to the station platform and the views of both Network Rail and the Train Operator. In the hearing mention was made of the sale of alcohol at Hitchin Railway Station. However this was viewed as very different to Stevenage and not relevant to this application.

The option of a short term licence as a trial was considered but not thought appropriate. The same issues would still arise.

Following due consideration, all parties were invited back into the meeting.

The Committee having considered the matter carefully and taking into account all the relevant factors, **RESOLVED** that the application be refused on the basis of Public Safety and the evidence provided at the hearing from the British Transport Police, Hertfordshire Constabulary and the Applicant, in conjunction with the Council's Licensing Policy and stated Licensing Objectives. The Applicant was advised of his right of appeal to the Magistrates' Court against the above decision within 21 days of the date of the decision (16 August 2021).

- 2. The Licensing Officer will outline the reason for the hearing and report on the facts of the case. Members of the Committee, the Responsible Authority representatives and Premises Licence Holder (and/or representative) may ask questions of the Licensing Officer.
- 3. The Responsible Authority representatives may then state their case, calling any witnesses.
- 4. With the Chair's permission, Members of the Committee and the Premises Licence Holder (and/or representative) may then ask questions of the Responsible Authority representatives.
- 5. The Premises Licence Holder (and/or representative) will state their case, calling any witnesses they wish.
- 6. With the Chair's permission, Members of the Committee and objectors may then ask questions of the Premises Licence Holder (and/or representative).
- 7. The Responsible Authority representatives are then invited to sum up.
- 8. The Premises Licence Holder (and/or representative) is then invited to sum up.
- 9. The Responsible Authority representatives, Premises Licence Holder (and representative) and the Licensing Officer will then be asked to retire for the Committee to consider the matter and make its decision.
- 10. At the conclusion of its deliberations, the Committee will EITHER invite all parties to return to the meeting to deliver its decision OR inform all parties of its decision in writing as soon as possible after the meeting. In either event, reasons will be given for the Committee's decision.

# APPLICATION TO REVIEW A PREMISES LICENCE – IBIS HOTEL, THE FORUM, DANESTRETE, STEVENAGE, SG1 1EJ.

### 1 PURPOSE

1.1 To determine an application for a review of the premises licence for Ibis Hotel, The Forum, Danestrete, Stevenage, SG1 1EJ. The application has been made by Hertfordshire Constabulary. Representations have been made by Stevenage Council's licensing team.

### 2 **RECOMMENDATIONS**

2.1 That the Committee reviews the evidence presented by the responsible authorities and the premises licence holder (and/or representatives) and determines what action should result in respect of the review application.

### 3 SUMMARY OF APPLICATION

3.1 Ibis Hotel is combined hotel and function suite. It has a premises licence for the performance of live music, the playing of recorded music and the performance of dance. It is also licensed to provide activities similar to the

three just mentioned. It is further licensed to exhibit films, and provide on and off sales of alcohol. In June, 2013. A 13 year old girl booked into the hotel for 2 nights. During her stay at the hotel she associated with various other residents. This situation was discovered by Police who launched an investigation into potential child abuse. This investigation was hindered by the Hotel failing to provide Police with CCTV footage. A combined Police and Council visit to the hotel revealed that the procedure for viewing or obtaining CCTV footage is an obstacle to the efficient investigation.of crime. The application for review was accepted as valid and duly made by the Council on 3<sup>rd</sup> September, 2021. A copy of the application is attached at Appendix A.

## 4 BACKGROUND INFORMATION

4.1 The Hotel is situated in the part of the town centre known as The Forum. The hotel is used Stevenage Council to accommodate homeless people. The hotel also accepts bookings from other people. At present the function room is not being used for entertainment or functions. The hotel does not appear to be making off sales of alcohol at present. A location map is attached at Appendix D. A copy of the premises licence eis attached at Appendix E.

## 5 **RESPONSIBLE AUTHORITIES**

- 5.1 Hertfordshire Constabulary has submitted the review in connection with the Licensing Objectives of the prevention of crime and disorder, and the protection of children from harm. Representations have been received from Stevenage Council's Licensing Responsible in connection with the Licensing Objectives of the prevention of crime and disorder and the prevention of public nuisance. The Police review details a number of incidents that have occurred at the hotel, and the inadequacy of the provision of CCTV coverage which hinders the investigation of these incidents. The Licensing Authority's representation re-inforce the evidence about inadequate CCTV provison, and point out the possibility of public nuisance because the hotel is licensed for off sales. The Licensing Authority also recommend changes to the premises licence conditions.
- 5.2 A copy of the Licensing Authority's representations is attached at Appendix C.

### TO PROTECT CHILDREN FROM HARM

There have been some recent CSE concerns raised around the Ibis hotel. This includes a non-recent rape and sexual activity with a child offence allegation that occurred in the hotel. This is currently going through the court process. The incident leading to the visit was an isolated case. There is another unrelated case going through the court process. This unrelated case is a rape allegation and sexual activity with a child which is alleged to have occurred at the IBIS in 2019. Is due in court March 2022.

In June 2021 a 13-year-old girl was able to book a room for two days at the hotel. It appears that sufficient checks were not conducted by the hotel into her age, on how she made the booking and how she was able to pay for the room or who she was staying with. It is believed she associated with adult males and females during the time she spent at the hotel.

Numerous requests have been made to the hotel to obtain CCTV to assist us to establishing if any offences have or haven't taken place and to identify any potential offenders during the females stay at the hotel. DPA forms were submitted from the outset by police. These requests were not met and now an email has been received stating that the CCTV is in fact now not available. See attached copy. on a girl of 13 years of age, had requested footage from the Hotel for a specific time and date, in relation to this offence, but had received nothing, and the CCTV footage was an integral part of the enquiry.

On our arrival I attended the Reception Desk where a lady, I now know as Marlene Damm, greeted us, and told us she was the Receptionist.

I requested to see the Manager, so as to explain our presence, and Marlene told me there was no Manager on Site. I then requested to see the person in charge of the Hotel

at that time, and she told me that she was the only person present, though added that there was a caretaker, who had stepped out to purchase paint.

I then requested that she contact somebody responsible for the hotel, to attend to meet with us.

At this time, with the agreement of Marlene, the Fire Officers started a tour of the building to complete their safety checks. (E mail from Fire and Rescue attached). After a few minutes, I was handed the Reception phone by Marlene, and on the other end was Hannah Chapman, General Manager of the Ibis Hotel, Stevenage. I explained why myself and colleagues were at the Hotel, to which she replied that she was not working today, and she was in Norfolk, so could not attend. I asked who was responsible for the Hotel in her absence, and she stated that if there were any problems on site, then Marlene could call the Manager of the Novotel, Knebworth Park, to attend.

Hannah said she would make a call and that a Mr. Tony Roworth from the Novotel would be down straight away. Marlene did take us to the top floor where there was an office on the Roof of the Hotel, and this was staffed, but the ladies there said that the running of the hotel was nothing to do with them. We then returned to the Reception area, which was quite busy with people, both visitors and Customers. After approximately 45 minutes Mr. Roworth arrived. I explained why we were there and with his agreement commenced a Licensing check/visit. Mr Roworth told me that he used to Manage the Ibis, so knew it well. Whilst walking around the premises, I asked the relevant licensing questions in relation to the Hotel, which are the conditions of the Licence.

When challenged about only one person (the Receptionist) being on site, in a Hotel of 90+ rooms (of which approximately 60+ were booked), Mr Roworth had no explanation, other than the fact he was fairly local should he be required. Mr Roworth was asked to produce the refusals book – he told me that there is not a refusals book as they believe it is not required, but did admit to making many refusals.

Asked if there was an incident book on site, Mr. Roworth did not know, and that he would have a look, but failed to produce one. He was then asked how incidents are recorded, and he was unable to give an answer.

The conversation came on to CCTV – Mr Roworth was unable to check that the CCTV was working, and he was unable to say how many cameras were in the

Hotel, asked how long the footage was kept, he stated that he believed it was 28 days, but was not sure.

Asked who had access to the system, and he explained that the system is managed away from site, so nobody had access at the Hotel. Therefore, it followed that nobody would know how to download for an emergency request. After visiting the whole site, it became apparent that there was no viewing monitor on site, so no members of staff are able to monitor the General hotel, including corridors etc.

The only person able to access the system is off site, in another area of Hertfordshire, and not available 24 hours to produce in an emergency. At the completion of the visit, it became obvious that there were areas of

concern with regard to various breaches of conditions.

- Follow up enquiries have been made of Mr Abel Wiseman, who manages the CCTV system, and an e mail has been received which is attached to the file for information. Unfortunately, due to the problems experienced by Mr. Wiseman, and the lack of any other person having access to the system, the CCTV is now unavailable, and the case has had to be discontinued Abel Wiseman mentioned a repair to the CCTV. Condition 10 of the premises licence requires any breakdown of the CCTV to be reported to the Police within 24 hours. He makes no mention of reporting the breakdown at any time, and Police were unaware of any breakdown.
- Abel Wiseman stated that the CCTV was replaced but, because of cost pressures, the new CCTV only retained recordings for 17 days. Condition 11 of the fficers, my requests for CCTV footage have been made as a result of receiving concerns from them that they have not received the requestd footage. This has meant that I have requested CCTV footage after the event, not on the day of the event.

At the completion of the visit, it became obvious that there were areas of concern with regard to various breaches of conditions.

exploitation (CSE). A referral had been made to the team after a 13-year-old female – xxxxxx had been located at the IBIS hotel. It transpired she had been there for two nights between the 15th and 17th June 2021. Police were only aware of this when her Mum called us having located her at the hotel.

I have called the hotel on 29th JUNE to obtain further details. I have spoken to Hannah Chapman – the hotel manager - over the phone who informed me that when xxxxxx checked in she was in company with a male described to be approximately 18 years old. She informed me that ID wasn't checked for either of them as 16 years is the minimum age to book a room. This male has gone up to the room with xxxxx but it is believed he did not stay the night. xxxxx was seen with another male, again described to be about 18 years old during her stay. There was no information on these males but I was told that the name on xxxxx booking was xxxxx. Due to this information I have requested to review the hotel CCTV. This is when I was told to email abel@a3le.uk . I now know this to be the email address of Abel WISMAN.

I have attended the IBIS the following day to see if I could review the CCTV in person as many facilities have a play back option within the premises but may only be able to download the footage remotely. The member of staff behind reception has informed me they have no screens for the CCTV at all – not even a live screen. She stated that she felt unsafe working at the hotel, especially overnight when they usually work alone. Even during the day, she was there with a member of the maintenance team and they were the only staff on duty.

I have sent an email on 2nd July at 0834hrs requesting the CCTV. I have received a prompt response to this at 0847hrs stating the footage could be shared and WISMAN has requested a form and description of xxxxx. Due to operational requirements I did not see this email until later in the day. The form requested I took to mean a DPA request, which is required when asking for CCTV. I have sent over a DPA request along with a photo of xxxxx.

# Witness Statement

Continuation of Statement of Sarah LANE I have heard nothing further so have sent chaser emails on 5th July, 12th July and 16th July. In between that I have tried to contact WISMAN using the phone numbers on his email signature. Two of the numbers did not connect. I have managed to get through to a switch board via number 02088422011. I was put through to WISMAN's extension but the phone went unanswered. On the 15th July I was again put through to WISMAN's phone. It was answered this time but by another member of staff - I do not recall his name. I was informed that WISMAN was the only person to assist with IBIS CCTV and I was advised to email him as he was currently working from home.

On the 12th July I have emailed CHAPMAN asking if she could assist me with obtaining the CCTV. CHAPMAN has replied the following day stating that the CCTV operative had asked for more information which she had provided but other than that there was nothing she could do and suggested I email again. I do not know what further information was asked.

Due to the difficulties with obtaining the CCTV and concerned with the fact a 13-year-old had been able to stay at the hotel for two nights. I have been liaised with DC 712 AFOLABI. DC AFOLABI is the Hertfordshire lead for OP MAKESAFE. OP MAKESAFE is a national initiative focused on raising awareness of CSE within the business sector, including hotels and encourage them to alert the police to prevent harm coming to the young person. Having discussed it, we both felt that a CSE awareness training day would greatly benefit the hotel. As part of this discussion we have also met with Gillian AKROYD 7779 from the Community Safety Licensing Team.

This led to a joint visit to the IBIS on 4th August 2021. During this visit it has again been asked about CCTV. No manager from the IBIS was available but one from a partner hotel has agreed to come down. Prior to their arrival we have been taken to the Head office, which is within the Hotel building. I have explained to Geraldine MULLINS - director of commercial at the hotel about the CCTV difficulties and she has gone to contact WISMAN. She has returned and informed me that WISMAN stated if a request was made, he would have downloaded it, but he had been having issues with discs. She has then asked me to forward on the emails, including the DPA so it could be escalated. I have sent this over whilst still at the hotel.

The manager - Tony Roworth has arrived and was unable to assist any further with the CCTV. He couldn't understand why if it had been asked for it wouldn't have been downloaded. At the time of writing this statement, I am still yet to receive any form of update on the status on the CCTV.

It is deeply frustrating that I have received no confirmation one way or the other regarding the CCTV footage especially when it involved the safeguarding of a vulnerable young person. As is quite commonplace with young people who have been victims of exploitation, it takes a while for them to speak out about it. xxxxxx is gradually talking about her stay at the hotel. The CCTV footage from her stay is potentially key evidence and possibly the only evidence we have.

This is my statement in relation to attending the ibis hotel, Danestrete, Stevenage Hertfordshire in relation to a joint agency visit.

I am DC 712 AFOLABI and I am a serving Detective Constable attached to the Hertfordshire Constabulary Child Sexual Exploitation Team. The purpose for this visit was in relation to Child Sexual Exploitation (CSE) concerns surrounding the hotel. A 13-year-old girl was able to book a room in the hotel between 15<sup>th</sup> to 17<sup>th</sup> June 2021, with no verification checks. This was reported to my team to investigate as a child protection investigation. My colleague PC 2703 LANE had liaised with the hotel on a number of occasions to see if there was any CCTV available.

The request was necessary to see if any offences had been recorded on the hotel CCTV and to see if this vulnerable 13-year-old girl had come to any risk. There was further information that this young girl had associated with older males and females and on one occasion was so drunk she had to be carried to a room. As of 4<sup>th</sup> August 2021, no CCTV has been provided to any police officer, police staff or licensing official to support our investigation.

There were also concerns around their compliance to Fire Safety Regulations, as the hotel had been given an action plan by Hertfordshire Fire and Rescue in September 2020.

Continuation of Statement of <u>Ayodeji AFOLABI</u> At 0930hrs on Wednesday 4<sup>th</sup> August 2021, myself, DS 2438 NORTHWAY, PC 2703 LANE, Hertfordshire Fire and Rescue, Stevenage Borough Council Licensing, Stevenage Safer Neighbourhood Team and Stevenage Community Safety Unit attended the hotel.

We were met by Marlene DAMM who was a receptionist. She did her best to put us in contact with the General Manger for the hotel and senior management from Head office. She also told me that she doesn't feel safe working at the hotel especially at night as she works on her own. Apart form a maintenance person who was out buying paint at the time of our arrival she works on her own for large parts of her shift during the day and at night. She also had concerns that she has no access to CCTV. She cannot download it or review it and there is no link to see a live feed for the CCTV. There was also no DSP on site.

At the time of our visit there was 78 people in 61 rooms, so in case of a fire she would not have been able to safely get persons out of the hotel. She was also scared to tell her bosses as she was in fear of being reprimanded for telling us. I informed her that I would speak to the local officers to drive by and go in and see her and her other colleague that works the opposite shift to her to provide support and reassurance. I also provided her phone numbers to call in case of an emergency.

The action plan issued 9 September 2020 has some points which have not yet been addressed and we have spoken to Tony Roworth about this expressing our disappointment and reminding him that we have powers to escalate our position to take enforcement action.

We intend to hold a review meeting with Tony Roworth, Hannah Chapman any other interested parties from Fairview Hotels (7 September pencilled in) which gives them a month to address the issues raised or provide a satisfactory reason for the delay.

We will look at our options following that meeting.

Apologies for the slow reaction, I will try and explain below.

First about the recordings, as many if not all DVR/NVR machines ours is set to rotate recordings (auto over write)

Due to changes to the system, A a repair and B replaced cameras, we at current have no more than 17 days (with luck or 14 without, depending on activity) recording, we previously always easily reached 30 days, I have failed to notice this.

It was already highly unlikely on the 2<sup>nd</sup> we had any images left of the incident date of 15<sup>th</sup> of June Even at 2nd of July s not sure images of the 15th of June were available.

As repairs had taken place shortly before this date (2 -3 weeks) I was unaware of the shortened recording history, and answered questions based upon experience.

Around the same date I was diagnosed with severe hypertension and type 2 diabates as well as an internal infection that has yet to be determined, so I must admit my mind was not 100% on the job at hand.

Sadly enough this does not make the images appear, as I said as of today my range goes back to July 18/19

Though I'm not happy yet with the current 14 day capacity (varies between 14 and 18 days) in these dire times with restrictions on investments, due to the business being severely impacted by COVID19 the cost of replacing the nvr (2) with much larger capacity is cost prohibiting and I was feeling that the time was enough for the time being (my reasoning being that requests usually are same day) and I would look to expand again one business returned to slightly normal

Stevenage police knows I normally go out of my was to accommodate them, and I'm very sorry not to be able to assist them in this case.

Whilst in the reception area I asked to Ms Damm to show me the control for the Hotel's CCTV system. She explained to me that there was no control for the CCTV system at the Hotel, and no monitors on which to view live CCTV footage. I asked her what happened if the Police or the Council asked for CCTV footage. She explained that an e-mail was sent to head office. When I asked where head office was, she told me It was upstairs. Ms Damm took PLO Akroyd and myself upstairs to the head office. The control for the CCTV wasn't there. Nor were there any monitors for viewing CCTV footage. In charge of the office was the director of commerce, Geraldine Mullins. She explained that if CCTV footage was required they contacted Abel Wisman who didn't work at the Hotel.

Mr Roworth subsequently arrived at the Hotel. He gave us a tour of the building. I didn't see any CCTV monitors anywhere in the building. After the tour PLO Akroyd and myself asked him about the CCTV and other matters. Mr Roworth explained that if anyone required copies of CCTV footage Mr Wisman had to be contacted. He would then download the footage. If there was a requirement just to view footage, again Mr Wisman had to be contacted and he would try to link the CCTV to any suitable screen that was available, such as a desktop computer.

In Annex 2 of the premises licence, under the heading "Function Suite", Condition 7 requires an incident record to be kept. Mr Roworth was unable to produce the incident record. Similarly, under Condition 15, a refusals log for the refusal of sales of alcohol must be maintained. Mr Roworth was unable to produce the refusals log.

PLO Akroyd, as part of her representations, has produced a log of criminal incidents that have occurred at the Hotel. It includes several assaults and a rape. This shows a clear need for the Police to have access to CCTV footage in a timely manner. This list of incidents also shows that the safety of staff working at the Hotel would be improved if they had a monitor(s) to enable them to view activity throughout the Hotel. PLO Akroyd has also produced a copy of an email from Mr Wisman that shows that Condition 11 of the premises licence has been flouted in connection with the length of time that CCTV footage should be retained. Because of Mr Wisman's behaviour/attitude I do not believe that the issues around access to CCTV can be resolved informally. Conditions concerning CCTV access need to be imposed on the licence through a review of the licence.

I request the following amendments to licence conditions listed in Annex 2 of the premises licence: Condition 9 to read: "The premises will be equipped with a CCTV system that covers all the entrance and exits to the Hotel, all the public areas of the Hotel including all the entertainment facilities on the first floor, all the areas that serve Hotel resident and visitors to the entertainment facilities with food and/or drink, and all the corridors and other open areas on the floors where Hotel residents have their rooms. The quality of the images should be of a standard that is Page 60

acceptable to Hertfordshire Constabulary, including a full image of the faces of people entering the premises to such a standard that the images can be used for identification premises. The CCTV will be in operation and recording 24 hours a day."

Condition 10 amended to read: "The local Hertfordshire Constabulary licensing officer will be informed by e-mail within 24 hours in the event of the breakdown of the CCTV recording equipment. The equipment is to be repaired and in operation as soon as possible."

Condition 11 amended to read: "CCTV images to be kept for a minimum of 31 days and produced to a Police Officer, Police Licensing Officer, Police and Community Safety Officer, Stevenage Council licensing officer or other Stevenage Council authorised officer within 48 hours of a request. The images should be provided in a format that is viewable by the person requesting them. CCTV images will be date and time dated. CCTV images shall be available for immediate viewing on a monitor at the Hotel by all the categories of person mentioned above. There shall be at least one CCTV monitor in the reception or front office of the Hotel for staff to monitor activity within the Hotel. A member of the staff who can operate the CCTV system shall be on duty at all times."

I also request that further conditions in Annex 2 of the licence are amended:

Condition 7 amended to read: "An incident record log shall be maintained, either written or electronically recorded, of the following matters:

- A. All incidents of crime or disorder that occur at the Hotel or are reported to Hotel staff.
- B. All calls to made to Police about situations other than crime and disorder.
- C. All refusals of alcohol sales.
- D. All visits by Police or other responsible authority officers.
- All evictions of guests or customers. E.
- F. A record of the times worked by SIA staff, including their name and badge number.
- G. A record of any faults affecting the CCTV system.

This log shall be available for immediate viewing, upon request, by Police officers, Police licensing officers, Police community safety officers, Stevenage Council licensing officers and other Stevenage council authorised officers." Condition 14 amended to read: " A Challenge 25 policy shall be adopted for alcohol sales. Posters advising customers of the operation of Challenge 25 shall be displayed in prominent places near the till at sales bars. A record of alcohol sale refusals will be kept as detailed in Condition 7 and available for viewing as detailed in Condition 7."

Condition 15 to be deleted, and Conditions 16 to 19 renumbered accordingly.

The Hotel is licensed for both the on and of sale of alcohol. The conditions of the licence allow the off sale until 2am every morning. I am not aware of the Hotel conducting off-sales but I believe it to be unsuitable for the Hotel to be conducting off-sales. Off- sales by the Hotel has the potential to attract people who would drink in public in the vicinity causing a nuisance to passers-by and adjacent businesses. The list of incidents provided by PLO Akroyd indicates that the Hotel attracts people, some of whom have the potential to be street drinkers. I request that the authority to conduct off-sales is removed from the licence.

I request that the premises licence is suspended for 2 months whilst the amendments to the licence conditions I have requested are implemented. The suspension is not to be lifted until the local Police and Council licensing officers are satisfied the amendments have been correctly implemented. If the amendments are implemented earlier, the Police and Council to be advised and the suspension lifted accordingly if they are satisfied the amendments have been implemented correctly.



### ANNEX 1 - MANDATORY CONDITIONS

- 1. No supply of alcohol may be made under the premises licence -
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 6. The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: 1/2 pint;
    - (ii) gin, rum, vodka or whisky: 25 ml Page 68

(iii) still wine in a glass: 125 ml;

- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 7. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of this condition -

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula -

 $\mathsf{P} = \mathsf{D} + (\mathsf{D} \times \mathsf{V})$ 

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence.
   (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8. Where the permitted price would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 9. (1) Sub-paragraph (2) applies where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the explry of the period of 14 days beginning on the second day.

### ANNEX 2 – CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Alcohol shall not be sold or supplied except during permitted hours as shown in Part M - the sale by retail of alcohol for consumption ON and OFF the premises.

The above restrictions do not prohibit:

a)the consumption of the alcohol on the premises during the first twenty minutes after the above hours;

b)the taking of the alcohol from the premises, (unless the alcohol is supplied or taken in an open vessel,) during the first twenty minutes after the above hours;

c)the consumption of the alcohol on the premises by persons taking meals there during the first thirty minutes after the above hours, if the alcohol was supplied for consumption ancillary to those meals;



d)consumption of the alcohol on the premises by, or, the taking, sale, or supply of alcohol to any person residing in the licensed premises;

e)the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

f)the sale of alcohol to a trader or club for the purposes of the trade or club;

g)the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

h)the taking of alcohol from the premises by a person residing there; or

i)the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or

j)the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

k)the provision of authorised licensable activities during the approved hours and on the agreed conditions in the first floor function and banqueting suite.

### **Function Suite**

Subject to compliance with the conditions listed below, the following licensable activities shall be permitted in the Forum Function and Banqueting Suite on the first floor ("the facilities") during the hours indicated:

B. Film10.00am to 2am Monday to Sunday

(with hours extended to 5am on New Year's Eve)

D, Boxing or Wrestling As above

Unless previously authorised by the licensing authority in writing, this will be limited to non-professional

boxing.

E. Live MusicAs above

F. Recorded MusicAs above

G. Performance of danceAs above

H. Similar entertainmentAs above

I. Late night refreshment insideAs above

J.Sale of alcohol on the premisesAs above

Opening hoursAs above plus 30 minutes clearance time following the terminal hour.

### Conditions applicable to licensed use of the facilities after 11pm:

1. The facilities will be limited to invitees or ticket holders only.

2. The authorisation of customers to use the facilities will be checked before they are allowed access to those facilities.

3.Details of the organisers of the function/s and the nature of the same will be maintained on site and available for inspection by an authorised Licensing Authority or Police officer, the Police Licensing Officer or PCSO, on request.

4."An event" will be defined as use of the facilities for ticketed events. In respect of an event the Police Licensing Officer will be given 14 days' notice of the event and the DPS will be responsible for ensuring that such details of the event as the Police Licensing Officer may require is provided to that officer. This condition will be applied to any TEN given in respect of such event.

5. In respect of an event SIA licensed security staff will be deployed as indicated unless the Police Licensing Officer waives or reduces such requirement on production of a risk assessment at least 14 days prior to the event. SIA licensed security staff will be on duty for 30 minutes Page tree the security staff will a minutes after the facilities

close. If there is no such waiver or reduction, the minimum number of security staff will be

a)For an event hosted for 100-200 guests - 2

b)For an event hosted for 201-400 guests - 2 until 2300 and 3 thereafter c)For an event hosted for 401-500 guests - 2 until 2300 and 4 thereafter d)For an event hosted for 501-620 guests - 2 until 2300; 3 to 0000 and 5 thereafter

6.If security personnel are used on any occasion they shall be required to wear their badge so that It may be clearly seen whilst they are on duty.

7.An incident record shall be maintained and produced on request to an authorised Licensing Authority or Police officer, the Police Licensing Officer or PCSO, on request.

8. The DPS or a member of staff aged 18 or over who has been authorised in writing by the DPS will be on duty at the premises throughout any function or event hosted for more than 100 guests.

9. The premises will be equipped with a CCTV system to include coverage of all entrances and exits to the facilities and front, side and rear entrances to the premises used by guests, and of the bar areas and dance floor. Images are to be of a standard that is to the reasonable satisfaction of the Hertfordshire Constabulary.

10.Hertfordshire Constabulary must be informed within 24 hours in the event of a breakdown of the CCTV recording equipment.

11.CCTV images shall be kept for a minimum of 28 days and produced to an authorised Police Officer, the Police Licensing Officer or PCSO if so requested (subject to the Data Protection Act 1998). The premises will be responsible for providing the appropriate medium to comply with any such request (eg flash drive, DVD or disc).

12.Except for customers permitted to temporarily leave and then re-enter the premises to, for example, smoke, there shall be no new admission to the facilities after midnight.

13.No child under the age of 16 shall be admitted to the facilities at any time for or during an event unless accompanied by a responsible adult.

14 A Challenge 25 policy shall be adopted.

15.A record of refusals shall be maintained and produced on request to an authorised Licensing Authority or Police officer on request.

16.Any member of staff responsible for the sale or supply of alcohol to guests will receive ongoing training in relation to the legislation governing the sale by retail of alcohol to include underage and proxy sales. A record of such training will be maintained on site and produced to an authorised Licensing Authority or police officer, Police Licensing Officer or PCSO, on request.

17.Notices will be clearly exhibited at the exits requiring customers to leave the premises and the area quickly and quietly and to have regard for any residents in the area.

18. Windows will be kept closed when musical regulated entertainment is played.

19.No music or amplified sound shall be generated within the facilities so as to give rise to a statutory nuisance within any private neighbouring dwelling.

### **INFORMATIVE** :

The premises licence holder and/or the designated premises supervisor are responsible as provided in the Licensing Act 2003 for ensuring compliance with these conditions.
