It was **RESOLVED** that the Minutes of the meeting of the Licensing Committee held on 16 August 2021 be approved as a correct record and signed by the Chair.

3 LICENSING APPLICATIONS - PROCEDURE

The Procedure for the hearing of Licensing Applications was noted.

4 APPLICATION FOR A VARIATION OF PREMISES LICENCE - THE CROOKED BILLET PUBLIC HOUSE - SYMONDS GREEN LANE, SYMONDS GREEN STEVENAGE, SG1 2HP.

The Chair welcomed all parties to the meeting and all those present introduced themselves.

The Licensing Officer presented a report outlining details of the application for a variation of premises licence for the Crooked Billet Public House – Symond Green Lane, Symonds Green Stevenage. The variation proposed extending the hours for the sale of alcohol from 23.00hrs to midnight on Sunday through to Thursday inclusive and extending the hours from midnight to 01.00hrs the following morning on Fridays and Saturdays. Late night refreshment would be extended from 23.30hrs to Midnight on Sundays through to Thursdays. On Friday and Saturday it will extended from Midnight to 1.00hrs the following morning. Opening Hours would be extended from 00.30hrs to 01.30hrs the following morning on Fridays and Saturdays. Further

changes to the licensing conditions were detailed in the officer report.

The Committee noted the three representations made by the residents, and listened carefully to the representation made by the applicant's solicitor. The Responsible Authorities had not commented on the application.

The Committee considered the variation of hours applied and the licensable activities, noting that there was no evidence to demonstrate that issuing of a premises licence would give rise to noise nuisance.

The Committee considered the hours and licensable activities applied for were reasonable, and also noted that should any nuisance arise from the premises, there were mechanisms to resolve it.

The Committee considered the following key assurances:

- 1. The assurance given by the applicant as to the nature of the proposed business, and the relationship with Green King as freeholders.
- 2. That no representation had been received from the police or any other regulatory enforcement agencies.
- 3. That whilst representations have been received, those concerns did not demonstrate evidence of any public nuisance.
- 4. That the extension to the licensing hours would allow the business to support the dining experience of customers.
- 5. That the Committee was pleased to note that there would be a telephone number and email address published on the website for any local concerns to be raised.
- 6. That the Committee noted the updated conditions to the licence.

The Licensing Committee considered all of the information put before them in the Officer's report, the relevant representations and the information supplied by the applicant at the hearing. In reaching their decision the Licensing Committee had due regard for all that they had read and heard, along with the Licensing objectives, the Licensing Act 2003, and the S182 Guidance and the Council's Licensing Policy Statement.

It was **RESOLVED** that the Committee grant the application for a variation of the premises licence.

The Applicant was advised of their right of appeal to the Magistrates' Court against the above decision within 21 days of the date of the decision (02 December 2021).

1 PURPOSE

1.1 To determine an application for a Temporary Event Notice for Ritty's Place, 6 Baker Street, Old Town, Stevenage.

Environmental Health has served an objection notice in respect of this application.

2 **RECOMMENDATIONS**

2.1 That the Committee reviews the objection presented by the responsible authority and any representation from the applicant (and/or representatives) and determines what action should result in respect of the Temporary Event Notice.

3 SUMMARY OF APPLICATION

3.1 Mr Clinton Moulton who is both the Director and premises licence holder of Ritty's Place Ltd has applied for the grant of a Temporary Event Notice for The sale by retail of alcohol, and the provision of regulated entertainment both on and off the premises at Ritty's Place, 6 Baker Street, Old Town, Stevenage SG1 3AL on Saturday 6th August 2022 between the hours of 12:00hrs and 23:00hrs. Mr Moulton has stated that the maximum number of people including staff, organisers or performers at any one time that he intends to allow to be present at the premises during the times stated will be 40. This application was accepted as valid and duly made by the Council on 15th July, 2022. A copy of the application is attached at Appendix A.

4 BACKGROUND INFORMATION

- 4.1 Ritty's Place is a small Caribbean restaurant situated at the end of Baker Street, junction with Church Road in the old town of Stevenage. Baker Street is accessible via the High Street, Middle Row and Church Road. A location map is attached at Appendix B.
- 4.2 The restaurant does currently have a premises licence which allows the sale of alcohol Monday to Sunday 12:00hrs until 23:30hrs, the provision of late night refreshment Monday to Sunday 23.00hrs until 23:30hrs and the playing of recorded music Monday to Sunday 07:00hrs until 23:00hrs (inside only). The premises opening hours are Monday to Sunday 07:00hrs until 00:00hrs. Annex 2, condition 5 of the premises licence requests that music played at the premises will be for background purposes only.
- 4.3 There are other refreshment outlets in Baker Street, Middle Row as well as premises which back onto Church Road which have a premises licence, none of which are licenced to play amplified music outside.
- 4.4 There is a history of unsubstantiated noise complaints from a local resident relating to the volume of music being emitted from the inside of these premises.

5 **RESPONSIBLE AUTHORITIES**

5.1 Representations have been received from Environmental Health on 19th July 2022. These concern the Licensing Objective the prevention of public nuisance. The applicant is intending to play amplified music inside and outside the premises until 23:00hrs to coincide with the Old Town Live music event on High Street, Stevenage which takes place on the same date. The Old Town Live event finishes at 22:00hrs. Environmental Health has concerns that if the Temporary Event notice is granted until 23:00hrs, people leaving the Old Town Live event at 22:00hrs may stop and gather outside of Ritty's Place causing public nuisance. There are also concerns with regards to amplified music being played both inside and outside of the premises. The premises are situated in a noise sensitive area as it is surrounded by residential accommodation.

5.2 Environmental Health has contacted Mr Clinton the premises user to discuss their objections and to try to come to an agreement which will allow the proposed licensable activities to proceed. Environmental Health has suggested that speakers should not face in the direction of the residential accommodation and that only background music is to be played outside in line with the existing level of music currently played inside the premises under the premises licence. It has also been suggested that the music outside the premises and the use of the outside seating area should cease at 22.00hrs to prevent public nuisance.

Mr Clinton Moulton had not yet responded in respect of the suggested modifications outlined by Environmental Health at the time this report was finalised.

A copy of the representation is attached at Appendix C.

6 INTERESTED PARTIES

6.1 Only the Police and Environmental Health have the right to make objections relating to a Temporary Event Notice.

7 IMPLICATIONS

7.1 Financial Implications

ANNEX 1 – MANDATORY CONDITIONS

- 1. No supply of alcohol may be made under the premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 6. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: 1/2 pint;
 - (i) gin, rum, vodka or whisky: 25 ml or 3prai and 27

(iii) still wine in a glass: 125 ml;

- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 7. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of this condition -

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula –

 $P = D + (D \times V)$

where -

- P is the permitted price, (i)
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- "relevant person" means, in relation to premises in respect of which there is in force a premises licence -(c) the holder of the premises licence. (i)

 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- "relevant person" means, in relation to premises in respect of which there is in force a club premises (d) certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (e)
- 8. Where the permitted price would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (1) Sub-paragraph (2) applies where the permitted price on a day ("the first day") would be different from the 9. permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

ANNEX 2 – CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

1) The Designated Premises Licence Holder shall ensure that the CCTV system shall continually record whilst the Premises is open for licensable activities and during all times when customers remain on the Premises. All recordings shall be stored for a minimum period of 30 days with date and time stamping.

2) Recordings shall be made available within 24 hours upon the request of the Police or authorised officer of the Licensing Authority providing such requests are in connection with the prevention or detection of crime. Recordings are to be supplied to in the form of digital download burned onto a DVD or CD disc.

3) The Premises must implement a "Challenge 25" policy whereby all customers who appear to be under 25 must produce photographic identification in the form of a passport, driving licence or Proof of Age Scheme (P.A.S.S) approved identification before being allowed to enter the Premises whilst licensable activities are taking place.

4) Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.

5) Music played at the premises will be for background purposes only.
